


Event attended: 2019 Jazz & Blues Concert Series

Lynne Plambeck AB1234 Report United Water Saticoy Replenishment Basin Event 2641 W. Los Angeles St, Oxnard (Saticoy Recharge Basins)

This public event was to celebrate the acquisition of 800 acre feet of article 21 water obtained with the help of the Fox Canyon Ground Water Management District for use as recharge to reduce salt water intrusion in the Oxnard Plain. The water was released from Lake Piru on June 3<sup>rd</sup> and began making its way down the river to the Saticoy spreading grounds. The replenishment basins were just beginning to fill up. Charts with maps and photos describing the ground water flows were presented along with a tour of the Freeman diversion. United will have a drone video of the release on line soon showing the water as it moves down the Santa Clara. Ventura Sup. Kelly Long was there and mentioned how glad she was that upper watershed folks were in attendance. (Steve Cole also attended).
