Rich Fadness from Reg 1 (North Coast Reg Water Quality Control Board) Report on Cyanotoxins (poisonous algae blooms)

Did a study (not designed to determine caused) how to monitor, and when they appear, Looking at Eel and Russian Rivers where dog deaths have occurred.. It seems to be the benthic bacteria that causes deaths (attaches to the bottom) especially to children and dogs. They identified 6 species that form matt of cyanotoxic algae. The reg board developed sign with pictures to inform the public. They determined that three kinds are the biggest danger. They are in an area of limited flow and easily detach from the river bottom so that they can be swallowed.

Drinking Water Qiality – presentation from micro plastics working group – Overview of the issue. Some systems have been identified for monitoring. State board planning for a Sept. meeting for monitoring plan proposed adoption date, discussing filtration levels and testing protocol. Tiffany Tran (Brown and Caldwell) – update on miroplastics Water Research Foundation Defining Exposure to micro plastics and another study through Arcadis – how to talk to customers about micro plastics

Crom6 – OHEA did a review – not completed. Said they think there is enough literature available

Nick Blair – gave the PFOS work group report met in late June to discuss how to respond to the EPA report. OHEA recommended some notification levels and response levels for another PFOS chemical.
