General Counsel Joe Byrne gave an informational presentation on the Surplus Land Act (Item 7).

General Counsel Joe Byrne discussed the Devils Den Water District Board of Directors vacancy and the process to fill it (Item 8).

General Manager's Report on Activities, Projects and Programs (Item 9).

Assistant General Manager Steve Cole reported the following past watermain breaks.

- On Monday, January 10, 2022 at approximately 3:30 PM, an 8" section of mainline started leaking in front of North Park Elementary School. Staff isolated the leak quickly and was able to avoid disruption at the school. However, approximately 33 homes and the school were out of water for approximately 5 hours. The mainline was repaired and service restored at approximately 8:00 PM.
- On Thursday, June 23, 2022 at approximately 3:45 PM, a 14" section of mainline ruptured at the intersection of Steinbeck Ave and The Old Road. Staff isolated the leak and minimized customer service outages to only a few fire services. The Fire Department was contacted as a precaution for Fire Watch. The mainline was repaired and service was restored by approximately 4:30 AM, Friday June 24, 2022.
- On Friday, July 15, 2022, at approximately 6:00 PM, a 14" section of mainline ruptured on Decoro Drive just West of the intersection with Dickason Drive. Staff quickly isolated the leak. The driver of one vehicle proceeded through the intersection and slipped into the sinkhole that was caused by the break, but according to the fire department there were no injuries. Valencia High School was initially out of water; however, the school was not in session. Staff was shortly able to return service to the school. Staff worked on repairing the mainline throughout the night and into the afternoon of July 16, 2022.

Position

SUMMARY

On July 13, 2022, Devil's Den Water District (DDWD) Director and Board President Jerry Gladbach passed away, which created an immediate vacancy on the DDWD Board of Directors. DDWD is a California water district whose Board is elected by owners of land within the District. Because the Santa Clarita Valley Water Agency (SCV Water) owns approximately 90% of the land in DDWD, this item is on the Agenda for SCV Water to designate a representative to recommend that the DDWD Board of Directors appoint to fill the vacancy.

DISCUSSION

DDWD Board of Directors is a five-person Board whose current membership includes three SCV Water Directors and one former SCV Water Director. As indicated above, former President Jerry Gladbach's passing created a vacancy on the Board.

In order to qualify to be elected or appointed to serve as a Board member, a person must be able to certify that they are: (a) a holder of title to land within the District; or (b) the legal representative of a holder of title to land within the District; or (c) a representative designated by a holder of title to land within the District. Because SCV Water owns the vast majority of the land within DDWD, the DDWD Board is composed of designated representatives of SCV Water. In the past, when there has been a vacancy, SCV Water has selected a designated representative to recommend to fill the position and the DDWD has then appointed such representative.

DDWD will consider filling the vacancy by appointment at its Board meeting on August 16, 2022. If a person is appointed to fill the vacant seat, they would serve the remainder of Director Gladbach's term, which will expire on December 1, 2023. A Notice of Vacancy was posted and it was requested that any person interested in being appointed to fill the vacant seat submit a written request for consideration to the SCV Water Board Secretary by August 4, 2022. The Secretary received timely written requests for consideration for this position from SCV Water Directors Ford and Orzechowski.

RECOMMENDATION

That the Board of Directors approves a designation and resolution of a representative to serve on the DDWD Board of Directors and recommend to the DDWD Board that such representative be appointed to fill the existing vacant seat.

DESIGNATION OF REPRESENTATIVE BY HOLDER OF TITLE TO LAND WITHIN THE DEVIL'S DEN WATER DISTRICT

The Santa Clarita Valley Water Agency ("SCV Water") is an owner of record of land within the Devil's Den Water District ('District"), specifically the land described in Exhibit A attached hereto (the "Land"). SCV Water hereby designates _____ as its representative pursuant to California Water Code, section 34700 (c), to permit said person also to be classified under law as a holder of title to land within the District for the Land. This designation is irrevocable during any period while said person shall be continuously serving as a director of the District, with the exception that this designation is automatically revoked in circumstances as follows: SCV Water ceases to hold title to the Land, or (1) (2) SCV Water's representative designated herein resigns in writing from such capacity, or dies, or SCV Water's representative designated herein does not file for the office (3) of director of the District in calendar year 2023. This designation document is a public record document of the District which shall be continuously on file at the District's office at 27234 Bouquet Canyon Road, Santa Clarita, CA 91350. SCV Water reserves the right to designate multiple representatives with respect to said parcel, and all such designations shall be filed as public records of the District. Any revocation of representative status which SCV Water causes shall be documented by a writing which shall be filed with the District and mailed to the representative at such address as is known to SCV Water. SCV Water's representative shall have no financial obligations with respect to said Land unless and until such representative shall become an owner of record of all or part of said Land.
