



ACWA Finance Committee

RE: 3<sup>rd</sup> Quarter 2019 financial report

ACWA had a very strong 3<sup>rd</sup> Quarter financial position. Included in the expenditures are a \$138,000 new build deposit and a deposit of \$52,000 for new furniture. ACWA's current cash position is \$400,000 increased over projections.

Our actual income was \$47,000 and our budget reflected a \$200,000 loss. A major portion of the savings was based on not filing a couple of salary positions. One position will be eliminated for the near future and salary and employment schedules will be presented again in January with the new two (2) year budget.


An RFP went out for a new auditor contract. Three (3) applicants responded and the committee has approved the rehire of the existing auditors with the required change of audit partner preparing the work.

In 2017 the investment policy was changed to allow for a better and broader investment focus. We have great results from CalTrust. Now in 2019 policy changes in cleanup of language in the policy.

New building update. Construction and move in date are ahead of schedule.

The sale price of the old building has been reduced.

Points of Interest:

1. Membership growth and retention is a key component of CSDA's strategic plan, and as such, it has been a good year. CSDA has experienced a net growth of 26 members for the year, with a total of 1,228 total members.

The retention goal for regular and associate members was 98% in 2019. The actual retention has been 98.5%. For the business affiliate memberships, the 2019 goal was 85% and the actual has been 83.5%. New members have contributed \$134,406 in dues revenue and dropped members represent a loss of \$78,455.
Earlier this year, CSDA launched a new web-based survey tool for collection and comparison of special district salary and benefit data. To date, more than 230 agencies have logged in and submitted their data for five common administrative categories. Those that have purchased a subscription to the results now have online access to the data through 2020.

4. In July, CSDA staff sent out an RFP for credit card payment processing services. Four proposals were submitted and reviewed by staff. GovPayNet was selected and the agreement will be considered by the CSDA board in November. The new program is expected to be launched in January, 2020.
