Known Risks

- Property rights
- Cyber/Malware recycled/modified threats
- Aging infrastructure
- Regulatory violations
- Worker safety
- Public safety
- Natural disasters

Known Unknown Risks

- Facilities without easements
- Cyber/Malware new threats (Zero-day)
- Location and severity of pipeline breaks
- Regulatory violations
- Accidents/Injuries
- Natural disasters

Examples of Known Knowns & Known Unknowns

- Property Rights Issues
 - Potential litigation
 - Easements
 - Acquisitions

Infrastructure Failures

- Major pipeline breaks
- Solar panel wind damage
- Import water supply

Water Quality Contamination and Compliance

- Known contaminants (PFAS, perchlorate, etc)
- Unknown contaminants (UCMR)
- Surface Water Treatment
- Technology Issues
 - Cyber attacks
 - Vulnerabilities
 - Widespread outages

- RMP/CUPA

- OSHA


• Financial & Human Capital Issues

- Loss of Revenue

Property Rights Example

- Easements
 - · Leak on a pipe between two homes
 - Isolated leak
 - Identified lack of easement
 - Pipeline to be abandoned
 - New pipeline connection to maintain adequate flow



Infrastructure Example

- Major Pipeline Breaks
 - Leaks are inevitable, but predicting the location of a leak is not an exact science
 - The following is used to help identify potential failure points and focus on strategic replacement plans
 - Material type
 - Material age
 - Leak frequency
 - Leak Location
 - Master Plan
 - Hydraulic modeling
 - Asset management





Infrastructure Example

- Sewer System
 - Pipeline Leaks
 - Manhole Failures
 - Lift Station Overflows

Water Quality Compliance Examples


- Changing State and Federal Drinking Water Regulations
 - Unregulated Contaminant Monitoring Rule
 - Emerging contaminants
- Drinking Water Compliance
 - Violations

Technology Examples

- External Threats
 - Phishing 61% increase overall compared to 2021
 - Data/Operational hacks
 - 3rd party breaches (Solarwinds, Microsoft, etc)
- Internal Threats
 - Personal accounts (gmail, facebook, twitter)
 - Human error
- Other Threats
 - Power outages
 - Hardware failures

- National Pollutant Discharge Elimination System Compliance
- Chemical Compliance (Chlorine & Ammonia)
- OSHA Compliance
- CARB/AQMD Compliance



Financial and Human Capital Examples

- Reduced Revenue
 - Does more conservation = less revenue
 - Limited revenue during a catastrophic event
- Staffing
 - Loss of legacy knowledge
 - Constricted/competitive labor market
- Claims Insurance Litigation
- Supply Chain Constraints



What is staff doing to mitigate risk?

Property Rights

- Hired staff to research and investigate
- Tracking new facilities
- Monthly meetings

Infrastructure

- Master Plan
 - Hydraulic model
 - Facility inventory
 - Proposed capital improvement projects
 - Asset management
- Pipeline Inspection/Replacement
 - Monthly meetings with ESS, TDOMS and GIS
 - Leak tracking
 - Pipeline priority identification
 - CCTV of sewer



What is staff doing to mitigate risk?

Water Quality

- Regulatory Agency engagement
- Participation and collaboration with various organizations and agencies (AWWA, ACWA, OCWD, BWP)

Technology

- Hiring security staff
- Dual authentication
- Staff training
- Security network groups (FBI, CISA, WaterISAC)

Safety Culture

- Training
- Inspections, audits, consultants
- Policies and Procedures
 - JPIA audits and assistance
 - Compliance standards
 - Audits
