**Report**

Hassan Amini reported that there was no impact from the earthquake. When they built the containment system along Soledad Cyn Rd. they did a geological study which showed that there could be issues so they way over excavated and compacted the soil.

The vapor extraction is complete. This conclusion was reached because they are not seeing any rebound when the system is turned off and then started again. They will continue monitoring during any future grading and development activities and will re-check every 5 years.

The will be continuing to monitor for particulates and stop work when the wind exceeds 25 mph, to avoid creating dust. Also, they stop if dust is being created due to other issues.

Jose Diaz said the soil clean up was completed but that the completion report must still be submitted, along with an operations and maintenance plan. He outlined the completion process in detail for the group. This should be finished by the end of the summer. There is some flexibility with restricted uses. Ground water cleanup is still estimated to take at least another 30 years.

Matt Stone and Steve Cole were limited in what they could say due to the litigation with Bermite, but talked about the various well closures and their causes.
