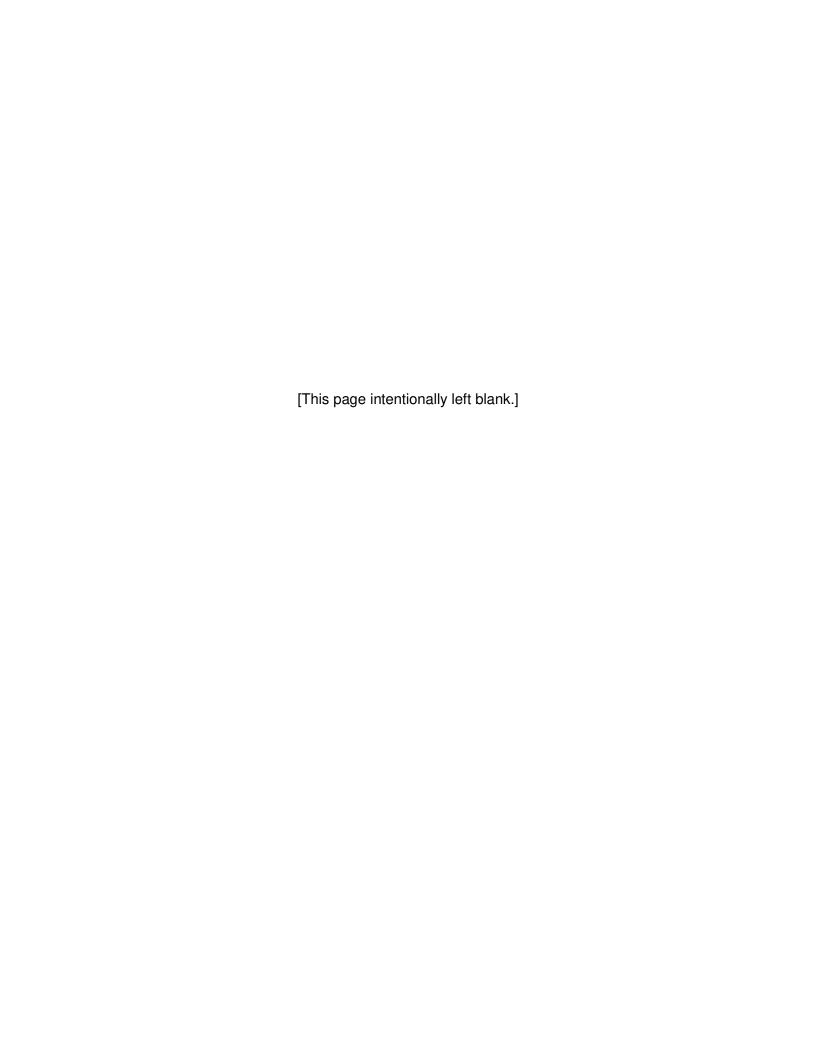

AB1234 Report Lynne Plambeck SCV GSA Virtual Meeting 4-5-21 2:30 to 4:45



There was a discussion of revisions to the stakeholders norms and procedures and a resolution regarding the matter was approved. The Board received an update on the Groundwater Sustainability Plan, the IRWP and Measure W as well as a report on the status of Bouquet Creek regarding the coalition of agencies working to resolve this issue. A funding increase for CV Strategies was approved. Postponement of the July 5<sup>th</sup> meeting was recommended.

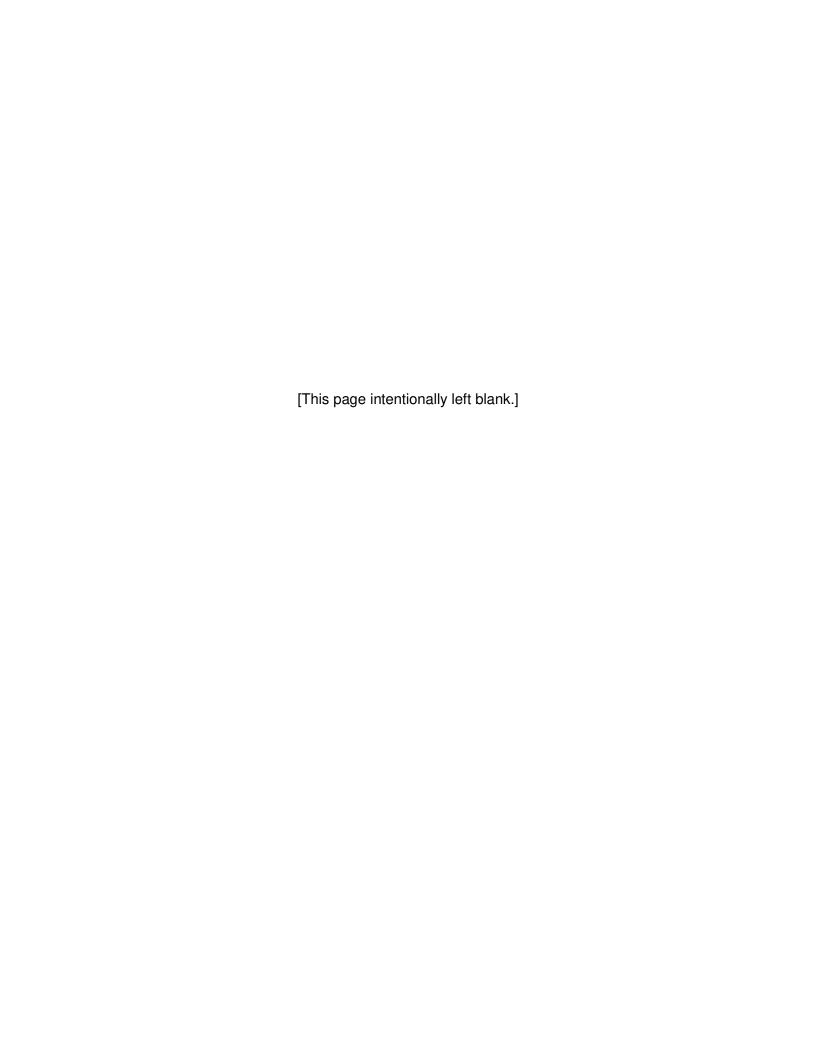

## **Points of Interest:**

Host: Shelly Berger of Association of Water Agencies of Ventura County

Guest speaker: Phil McGrath of McGrath Family Farm

Mr. McGrath shared information about his farm's adoption of regenerative farming practices, how those practices have an effect on our soil and water, how climate change is affecting farms, and their water needs.

- · Key points
  - McGrath Family Farm is located in Camarillo, CA
  - Participates in food and agricultural policy discussions/programs
  - Has adopted regenerative farming practices as one of three sites being studied by the Rodale Institute
  - Regenerative farming practices take into account labor, animals, and growing practices
  - Examples of regenerative growing practices
    - Plan crop programs using a multi-year/generational perspective rather than planning year-to-year
    - · Focus on soil health, which is key in farming
      - Less tillage/disturbance of soil to preserve microbial population
      - Use of roller crimpers to use biomass to suppress weeds instead of herbicides
    - Biological pest management
    - No use of genetically modified organisms
    - Use of compost
    - Succession crop planting
  - Benefits of regenerative farming
    - Helps combat climate change, which is clearly affecting farms, by taking carbon out of the air and putting it into the soil
    - Helps conserve water by keeping more life in the soil

- Helps reduce runoff of contaminants into water supplies due to less use of herbicides/fertilizers/insecticides
- · They need water
  - With this year being another dry year, they are encouraging water suppliers to expand resources to include banking, reservoirs, reverse osmosis systems, and recycled water systems to make water available to farms
- The farm offers tours to those interested in learning more and seeing the farm firsthand, and has a store where you can buy their harvested goods
