As I was reviewing the September 7th Board packet, I was still troubled why CALPERS would contract to increase the PPO premiums so much for out of state retirees. I decided to call CALPERS again today, September 2, 2021 to confirm the out of state rates again.

Fortunately, the person I had on the phone this time clarified that my out of state premium would be \$2,204.05 and not the \$2,461.63 that I originally thought and confirmed with CALPERS previously. Apparently, the previous CALPERS agent did not realized I was not a State retiree and I had thought PA only, was abbreviation for Pennsylvania state residents instead of "Public Agency". CALPERS never mentioned PA or State and distinguished the different rates in their 2021 out of state premiums, since the rates for both were the same.

I apologize for the misunderstanding and wasting your time. Please disregard my August 23, 2021 letter regarding my concerns on the 2022 out of state premium contribution.
