other provisions in the lease, all areas of the site outside of the perimeter fence are to remain in the possession of CLWA or its agents for dry farming "buffer use" purposes, except for a row of trees along the westerly edge of the site which shall be maintained by the City beginning with the commencement of the initial lease term.

- <u>Utilities and Property Access</u>. All utilities are to be underground. CLWA shall reserve in the lease all rights of way or other property interests reasonably needed by CLWA for ultimate development of all remaining CLWA property.
- <u>Liability and Insurance</u>. City shall indemnify, hold harmless and insure the interests of CLWA with respect to the site.
- Joint Recognition. A monument sign at the entrance to the site shall recognize the cooperation of City and CLWA with respect to the park and sports facilities. The name of the park shall be acceptable to CLWA.
- Commercial Activity. Commercial activity is not to be permitted on the site, except as mutually agreed by City and CLWA as being compatible with park and sports facility purposes. A negotiated percentage of any commercial revenue shall be paid by City to CLWA as additional rent.
- 4. Sewer Service Master Plan. CLWA shall prepare a storm and sanitary sewer master plan for the entire ownership of CLWA's land, and shall identify land areas to be reserved for storm and for sanitary sewers and/or leach fields within the site. City shall incorporate this storm and sanitary sewer master plan into the planning of its park and sports facility master plan. CLWA and City shall share sewer service construction costs on the site in proportion to the capacity required by each.
- 5. Untreated And/or Reclaimed Water Master Plan. CLWA shall prepare a feasibility study on immediate and longer term use of untreated and/or reclaimed water within the site. City shall design park and sports facilities to permit use of intreated and/or reclaimed water, and shall use untreated and/or teclaimed water on the site to the maximum extent legal and feasible when available.

SCV Water board approves appending Central Park's name to honor SHS shooting victims

Santa Clarita Valley Water Agency board members voted Tuesday to approve appending Certiral Park's name in honoring the victims of the deadly Saugus High School shooting, following heated commentary from residents who urged them to pass the designation.

The approved move in an 9-3 vote was to add "Central Park - In Memoriam of Gracie Muchlberger and Dominic Blackwell" onto the base of the west monument sign located at the entrance of the park, which currently has signage of the city and the water agency, along **Bouquet Canyon Road.**

The poard considered three options, recommended by an ad hoc committee created to consider the matter: append the park name, add a plaque with the same phrase on a pillar of the entry sign or make no change to the sign but provide the city with other alternatives for separate signage.

On Nov. 14, 2019, when Gracie Anne Muehlberger and Dominic Michael Blackwell died after a shocter opened fire on his fellow classmates at the school and then turned the weapon on himself, students, faculty and staff evacuated to Central Park to reunite with their loved ones. Thousands returned to the park on Nov. 17, 2019, to grieve the victims.

The Muchlberger and Blackwell families spearheaded efforts, including garnering more than 10,700 signatures in a petition (https://www.change.org/p/dedlcate-central-park-in-memoriam-of-gracie-muchlberger-and-dominic-blackwell), before the Santa Clarita City Council to append the flame.

On Tuesday, Bryan Muehlberger and Frank Blackwell, fathers of the victims, urged the water board to focus on the name addition as they proposed before the City Council, and said they would support the designation along the base of the west entry monument sign, ultimately influencing the water board to approve that option.

"This Central Park project will be an incredible step and continue to provide community members a place to acknowledge, to understand, to grieve and to heal," said Blackwell.

Several residents of the dozen who spoke during public comment criticized the water board for having to wait nearly two hours to speak on the matter while board members commended those who have resigned or whose terms will end, and demanded they approve appending the part name.

In August, council members voted unanimously in support but official name additions still required consent from the SCV Water Agency because the agency owns the land the park is built on and has final approval on all signage, including the name of the park, according to Bill Cooper, chair of the Central Park ad hoc committee.



A seven-page report (https://yourscvwater.com/wp-content/uploads/2020/12/SCV-Water-Board-Handout-121520-Item-8.1-Public-Comments-Central-Park.pdf), prepared by board member and ad hoc committee member Ed Colley, recommended to reject the proposed name addition, citing that placing the victims' names along a major public thoroughfare could incite others to mimic the tragedy and that "a memorial would best serve the community if it was in a destination in which the intentional visitor could reflect in peace and solitude."

Blackwell said the families have spoken to mental health professionals who have suggested that memorializing the victims in the proposed manner "is actually better."

The committee had even suggested providing funds to assist in building a water feature in conjunction with a possible place of reflection related to the tragic shooting as "many find the sounds of gently flowing water to be soothing and perhaps even healing."
