
## Director AB 1234 Report May 2, 2023

Meetings attended: Delta Conveyance Project Tour in Sacramento, CA.

On April 26, I attended the Delta Conveyance Project Alignment Tour organized and presented by the Delta Conveyance Design and Construction Authority (DCA) Executive Director and staff. The trip itinerary and attendee list is attached hereto. The points of interest are as follows:

- The tour, which was attended by representatives of SCV Water and the Kern County Water Agency
  (KCWA), began at the DCA offices in Sacramento and traveled to a number of locations, as identified in
  the itinerary. Throughout the trip, DCA Executive Director Graham Bradner narrated descriptions of
  the various proposed project features. Mr. Bradner's presentations were supplemented by video clips
  prepared for DCA.
- The first stop was at the Bethany Reservoir, which is the terminus point of proposed Delta Conveyance Project. Attendees were given the opportunity to walk the site and see the physical location of the proposed Bethany outlet structure.
- From Bethany the tour proceeded northward to Stockton with continued presentations from the project team. The Stockton stop provided an opportunity for a lunch break and conversations with fellow attendees.
- From Stockton, the tour continued northward to the Twin Cities area and the Twin Cities Launch shaft site. The group was able to see where the double launch shaft would be and how material extracted during tunnel boring operation would and stored on site. Reference was made during the presentations to the alignment site book that was prepared and distributed to all attendees.
- The tour then proceeded to the Hood area where two intake sites would be located along the Sacramento River.
- Leaving Hood, the group stopped at Intake Screens, Inc. (ISI) to hear the latest in intake screen
  technology and plans for use at the Delta Conveyance intakes. The visit allowed the group to see full

- The tour then returned to DCA offices in Sacramento.

I found the tour to be informative and beneficial in better understanding the alignment and operational considerations that are included in the Draft EIR.
