Dear Members of the Water Board,





#### Dear Board Secretary; April Jacobs-

I want to express my deep concern and disappointment in perpetrator, Vice President Mortensen, remaining in his seat on the board. Dan Mortensen has committed, and been found guilty of crimes against women, specifically his own spouse. This seems common and tolerable to this board and not the first time a board member has abused a spouse, or been accused of abuse. It is a sickening display of agency and misogyny to cultivate this behavior as normal and respectable. He must resign immediately.

I attended the swearing in session for the newly elected board members on Jan 6, 2021, and it was during that meeting that acute misogyny and negative attitude towards women was on full display by this board. A fellow board member had been nominated for the role of VP and had expressed that perhaps the role of VP should be a woman to show good faith parity to this male dominated board. It was also at this meeting that I first heard the word "GENITALIA" mentioned on ANY dais of ANY board meeting I have EVER attended in my life. Dan Mortensen stated that the board was "welcome to vote for him based in his "genitalia", somehow attempting to trivialize the very valid and logical supporting arguments in favor of the female board member who was equally as qualified as any male to serve in that role. This prompted inappropriate giggles from staff, and I knew in an instant that this

man/board has very little respect for women. We now see that playing out in a very public arena. Dan was later approved by all the MALES on the governing board to the role of Vice President. The optics in that moment was blinding, however completely lost on board President Martin. I want to also mention that another SCV Water board member at later meeting used the word "genitalia" when the discussion topic was a question to the board if any work contracts had ever been awarded to women owned corporations. This time member Orezechowski chimed in for only the 2nd time I have <a href="ever">ever</a> heard <a href="eyenitalia"</a> mentioned in a meeting. This time insisting that contracts should never be awarded based on "genitalia". Twice the word flowed from this agency and yet never heard anywhere else in a similar setting. Misogyny and sexism abound at SCV Water. I have heard that this was also the reason the previous GM left.

Domestic violence is a very serious offense, and we should be taking a very stern approach in dealing with the perpetrator of this attack on women. Most women never report their abuse or their abuser for any number of reasons, but FEAR ranks highest on the list. Some may argue that both Dan's wife and daughter had retracted their statement, but there are many reasons people stay in an abusive relationship.

This has been excerpted from a World Health Organization (WHO) study:

The United Nations defines violence against women as "any act of gender-based violence that results in, or is likely to result in, physical, sexual, or mental harm or suffering to women, including threats of such acts, coercion or arbitrary deprivation of liberty, whether occurring in public or in private life."

Population-level surveys based on reports from survivors provide the most accurate estimates of the prevalence of intimate partner violence and sexual violence. A 2018 analysis of prevalence data from 2000-2018 across 161 countries and areas, conducted by WHO on behalf of the UN Interagency working group on violence against women, found that worldwide, nearly 1 in 3, or 30%, of women have been subjected to physical and/or sexual violence by an intimate partner or non-partner sexual violence or both

## Risk factors for both intimate partner and sexual violence include: (WHO study)

- lower levels of education (perpetration of sexual violence and experience of sexual violence);
- a history of exposure to child maltreatment (perpetration and experience);
- witnessing family violence (perpetration and experience);
- antisocial personality disorder (perpetration);
- harmful use of alcohol (perpetration and experience);
- harmful masculine behaviours, including having multiple partners or attitudes that condone violence (perpetration);
- <u>community norms that privilege or ascribe higher status to men and lower status to women;</u>
- low levels of women's access to paid employment; and
- low level of gender equality (discriminatory laws, etc.).

There are several reasons why women do not report domestic violence. Major reasons behind why Domestic violence is frequently unreported: **Fear of the abuser**. **Fear of uncertainty. Fear of belief from family friends and authority.** I sincerely hope that Mrs. Mortensen and her daughter is getting all the support they need from friends and family. We can offer our support to the victims of this domestic violence perpetrated against them in any number of ways, but first and foremost the board must address the behavior of the perpetrator and how he brings shame and embarrassment to this governing board. He must resign. In the name of his victims, he MUST RESIGN.

I strongly urge the board to strip Dan Mortensen from his elevated status as VICE PRESIDENT and the perpetrator, Mr. Mortensen, must immediately remove himself from the board entirely. This is completely unacceptable behavior from a publicly elected board member and husband.
