

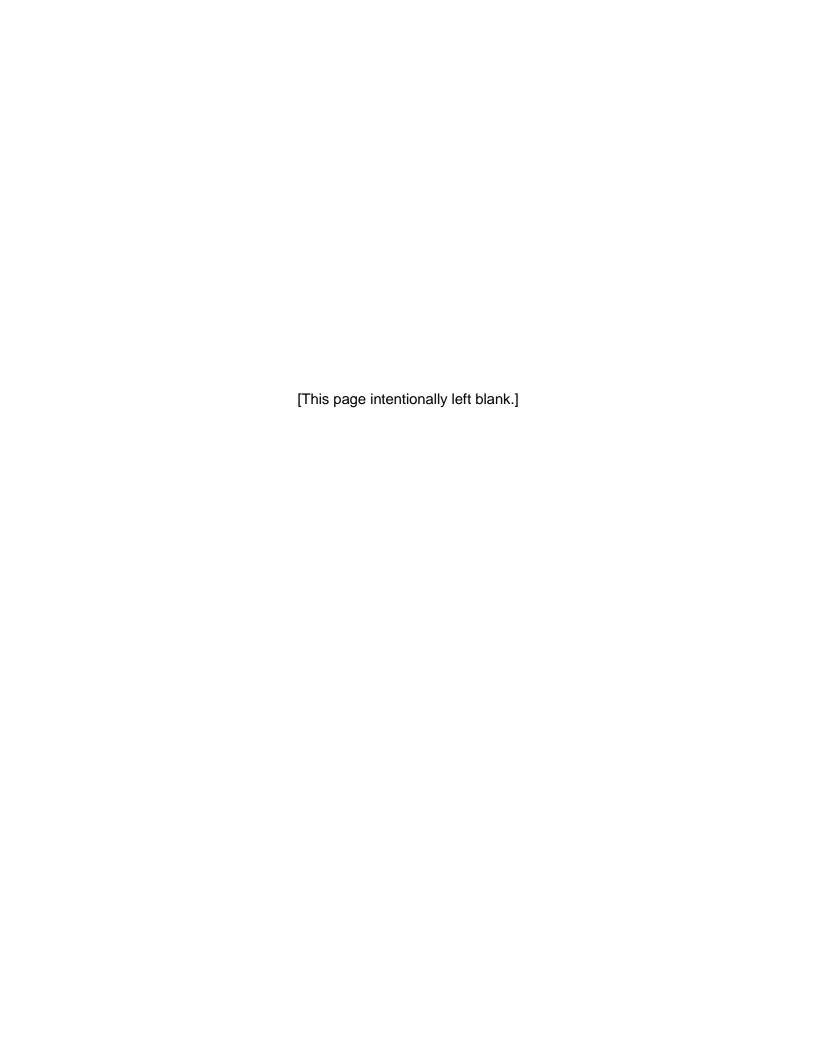
SCV Water Board meeting to be presented at: February 5, 2019

#### Points of Interest:

- 1. This was the first meeting of the CSDA Membership Committee for 2019. Chairman Ralph Emerson opened the meeting welcoming the committee members and asked each member to introduce themselves and state their affiliation.
- 2. CSDA Member Services Director, Cathrine Lemaire, reviewed the responsibility of the committee, as a whole, and further explained expectations and responsibilities of individual members:

  Committee: responsible for assisting the Association in the recruitment of new members, member retention, development of new member benefits, and review of current programs.

  Individual members: should attend all meetings and be engaged in the process; should be willing to assist staff to help achieve committee goals through email, phone calls, face-to-face contact with peers; must be a member of an organization that is a current regular, associate or business affiliate member of CSDA.
- 3. The CSDA Core and Value-Added Benefits were then reviewed in detail. It is an extensive and impressive list of benefits that are made available to members of CSDA. This information can be viewed at csda.net. It is recommended that those interested in learning more about programs and benefits of CSDA should establish a user name and password to gain access to all the member-only information. Later in the meeting, CSDA staff made an excellent demo presentation of the CSDA website and online "Communities." There is quite a lot of very useful (and relevant) information available and I would encourage directors to take some time to familiarize yourself with what is available, if you have not already done so.
- 4. CSDA staff gave an update presentation on membership recruitment and retention. At the time the agenda was prepared, 91% of members were paid-up for 2019. A discussing of the dues structure followed and it was pointed out that member dues are based on operating revenues and divided into a number of steps.
- 5. The latter part of the meeting was an open format discussion of "Chapter" activities around the state. Jacque McMillan, who attended representing MWD, is working on establishing a Los Angeles Chapter. Stay tuned for updates on that effort.
- 6. Personal note: The meeting was held in the Earl Sayre SDRMA Board room, and the facilities were very effective. The sound, including the voices of call-in participants, was quite good and the video display was very large with very sharp resolution. Agency staff who might be considering any upgrades to SCVWA meeting facilities (especially call-in sound amplification) would benefit from a tour and demonstration of these facilities.





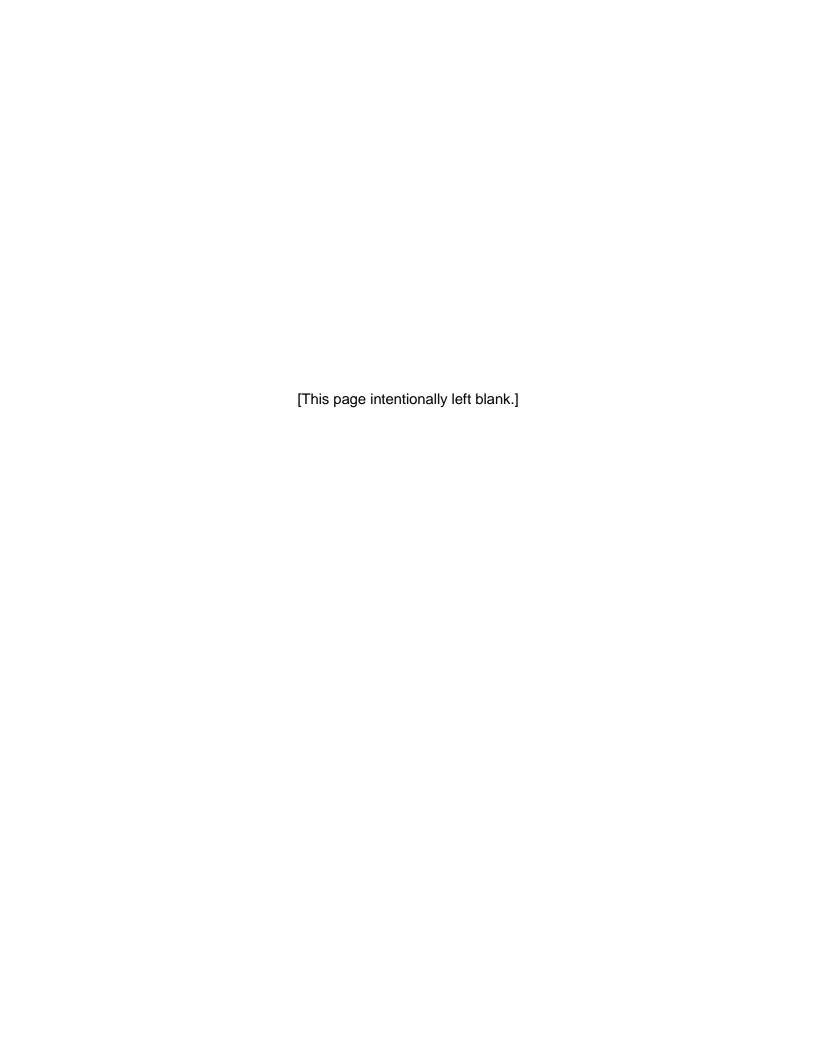

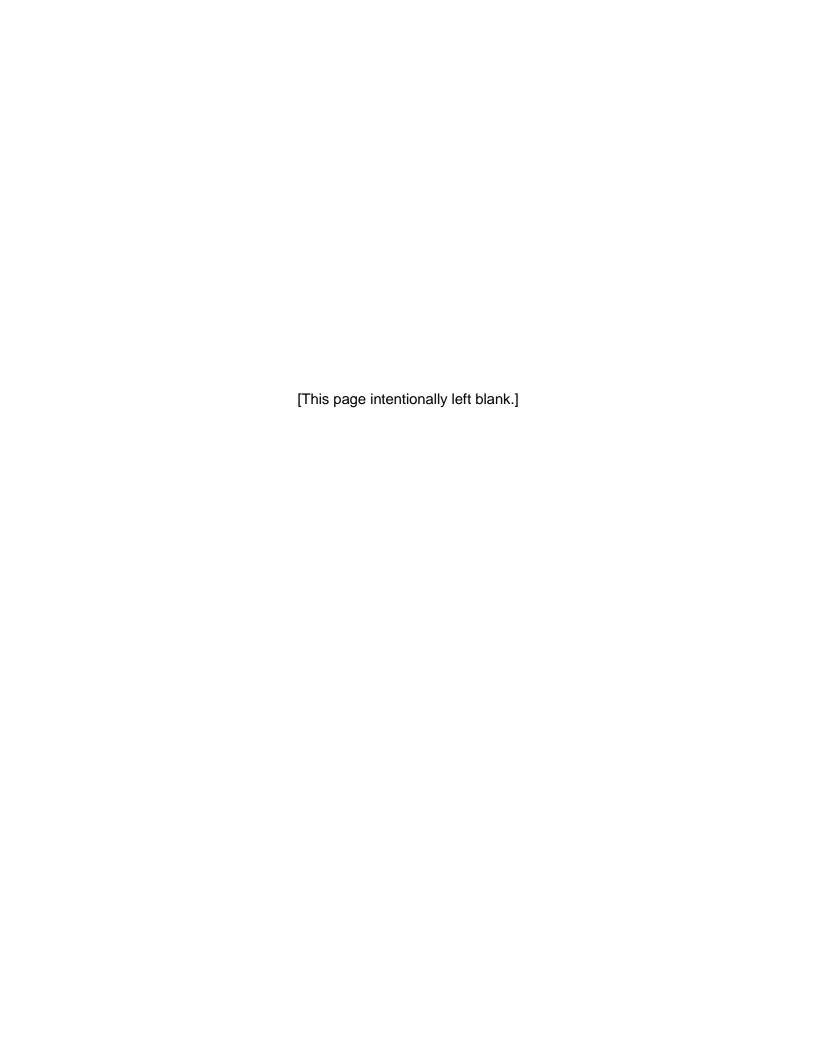

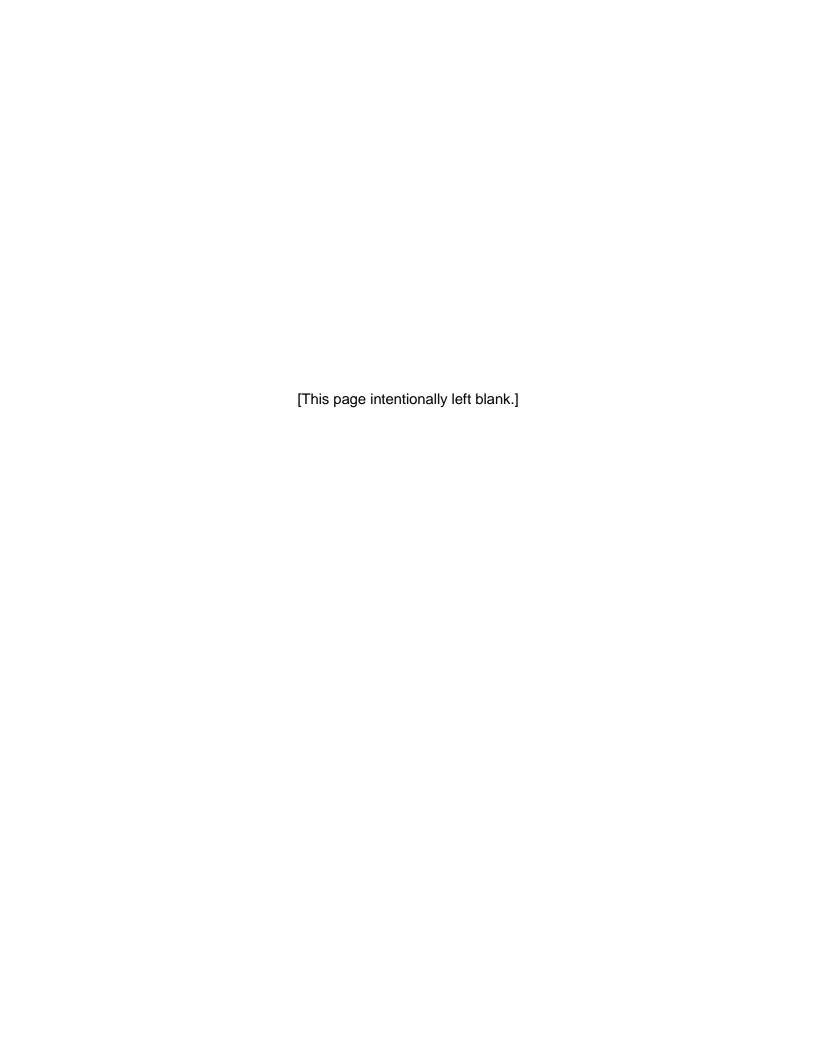

In attendance were approximately 230 local business people and community leaders.

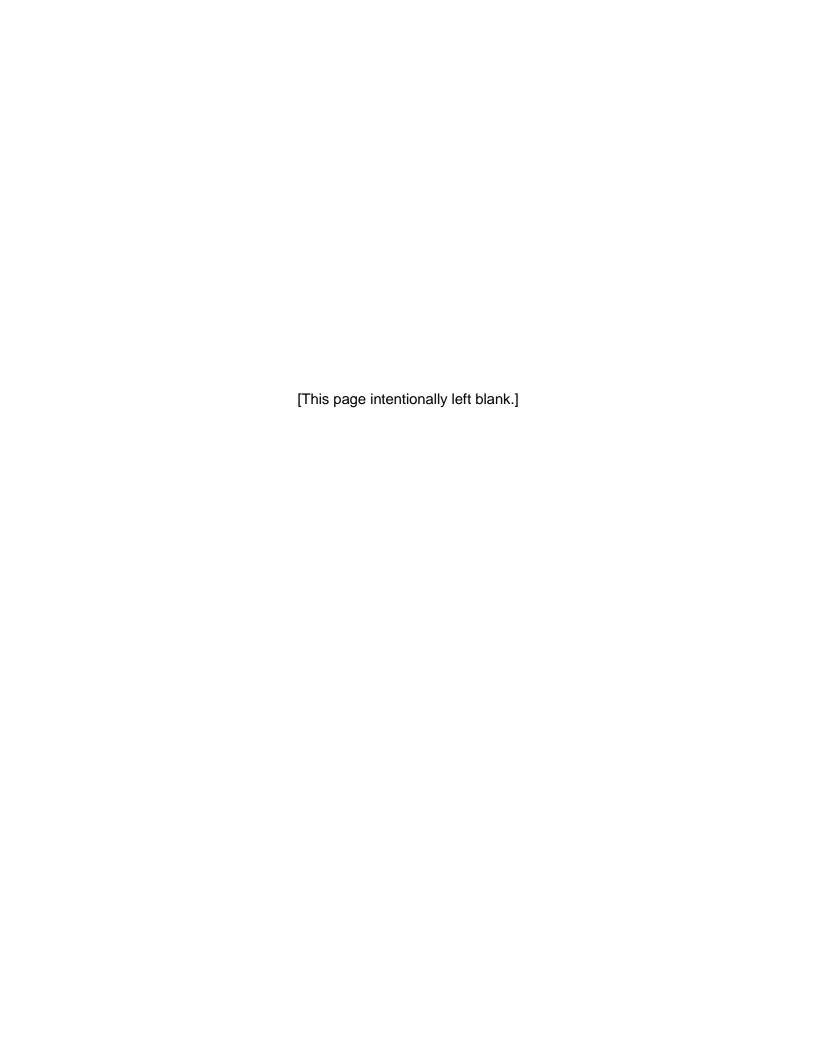
Discussion included the need for and the process of getting more businesses to relocate in our business hub.
