The discussion included an update on DWR Proposed Process for Prop 1 Round of IRWM Implementation Funding.

Preeti Ghuman, Project Engineer, from the Sanitation District gave an overview of Santa Clarita Valley Sanitation District's Water Softener Removal Program, including a history and statistics about how many have been removed. She answered several questions about how monitoring is conducted and how they work with store managers to reduce the sale of salts. She also answered questions regarding salt water swimming pools.

Russ Bryden or Matt Frary from the County of Los Angeles gave a summary of the Los Angeles County Safe Clean Water Program, a tax assessment to pay for storm water improvement, including storm water capture and water quality information that the County is set to place on the November ballot. Questions arose about why our area is lumped with Antelope Valley and how the tax would be calculated.

Heather Merenda from the City of Santa Clarita gave an update on the Disadvantaged Community Involvement Program including how projects will be submitted and what projects are being considered.

Lara Meeker, Lower Watershed coordinator reported on the activities going on in the Lower water shed IRWP committee

The Energy Committee:

ACWA has put out an RFP for a "Preferred Provider" for a combination solar/battery, and it should be in place by this August.

There was a presentation on Climate Registry: CalEPA's Water-Energy Nexus Registry: a program to register emissions and report the carbon footprint. It is a voluntary program now but in my opinion that will change to a requirement. It is feared that way to reduce carbon emissions is to reduce water usage.

I was appointed to a work group regarding the carbon footprints of various water related operations.

Federal Affairs Committee:

The highlight of the meeting was a short talk by Assistant Secretary of Interior, David Bernhart. He commented that the Trump Administration is way ahead of schedule and that there will be a major reorganization of the Executive Branch, and it will be done by this Fall. I had the opportunity to talk briefly with him and described our water reclamation program and the need for Federal Assistance. He acknowledged the wisdom of such a program and understood the need for financial assistance, along with many others.

Also from Washington D. C. was Austin Ewell, Deputy Assistant Secretary of Interior for Water and Science. Austin is from Fresno and therefore understands California water. He said that they are improving the publication of information, striving for environmental balance, and empowering local communities. He also pointed out that the Secretary of Interior has put out an edict that EIS's must be completed in less than a year and to be less than 100 pages. There may be exceptions, but they will be few and difficult to obtain the exception.

The budgets for the Corps of Engineers is \$7.3billion and the Bureau of Reclamation is \$1.6billion.

There is money in the WIIN program for water storage.

There are 5 proposals regarding changes to the regulations for Endangered Species at the Office of Management and Budget.

I appreciate the opportunity of being on these 2 committees.

Points of Interest: At the time of the meeting, Congress was gearing up to deal with the appropriations bill. The House will push for all bills and the Senate will mark them up, only the defense budget will get to the Senate floor. The House will not accept the White House's cuts. They will increase the budgets for the Corps of Engineers and the Bureau of Reclamation. The budget for the Bureau of Reclamation for 2020 is on the Assistant Secretary's desk and NWRA will go with BoR when the budget goes to the Office of Management and Budget. There is not enough money for wildfires proposed which means a lot of work to get it increased. The big divide is the eastern Democrats versus western Democrats.

The bill, no later than March 1, 2019, would require the state board to provide written notice to cure to all public agencies, private water companies, or mutual water companies that operate a public water system that has either less than 3,000 service connections or that serves less than 10,000 people, and are not in compliance with one or more state or federal primary drinking water standard maximum contaminant levels as of December 31, 2018, and for 4 consecutive quarters, as specified.

Current law requires the department, within 60 days of receiving this project information, to provide advanced payment of 50% of the grant award for those projects that satisfy specified criteria. The bill, until January 1, 2025, would require the department to provide a project proponent that requests and demonstrates a need for advanced payment with advanced payment for those projects of \$500,000 or 50% of the grant award, whichever is less.

This bill would extend the operation of those provisions to January 1, 2024.

This bill would also require, upon delivery to a job site, as defined, each landscape plant or a representative number of each landscape plant, as determined by the Secretary of Food and Agriculture, to be individually labeled as to its correct name in order to correctly identify nursery stock installed in outdoor landscapes that are subject to inspection under the Model Water Efficient Landscape Ordinance or any local water efficient landscape ordinance.

The act defines "disadvantaged community" for these purposes to mean a disadvantaged community that is in an unincorporated area, is in a mobilehome park, or is served by a mutual water company or small public water system. This bill would redefine "disadvantaged community" for these purposes to also include a disadvantaged community that is served by a state small water system or domestic well.

Current law prohibits an entity from substantially diverting or obstructing the natural flow of, or substantially changing or using any material from the bed, channel, or bank of, any river, stream, or lake, or from depositing certain material where it may pass into any river, stream, or lake, without first notifying the Department of Fish and Wildlife of that activity, and entering into a lake or streambed alteration agreement if required by the department to protect fish and wildlife resources. This bill would require the department, until January 1, 2023, to establish procedures for the issuance of a general agreement in lieu of an individual alteration agreement pursuant to these provisions. The bill would require the department to adopt general agreements, as specified, for these activities.

Would, if (1) the federal government takes action to enact a statute that, upon enactment, would require the removal or delisting of any river or segment of a river in California that is included in the national wild and scenic rivers system and not in the state wild and scenic rivers system; or (2) the secretary determines that the federal government by enactment of a statute or by executive order has exempted a river or segment of a river in California that is not in the state wild and scenic river system from the protection of certain federal provisions governing restrictions on water resources projects, require the secretary, after holding a public hearing on the issue, based on the information obtained through the public hearing, to determine whether the provision of state protection for the river or segment of the river that has been removed, delisted, or exempted from the federal wild and scenic rivers system is in the best interest of the state and, if so, to take specified actions, until December 31, 2025, to add the river or segment of a river to the state wild and scenic rivers system and to classify that river or segment of a river, as prescribed.

Current law authorizes a water replenishment district to establish an annual reserve fund not to exceed \$10,000,000, as adjusted annually to reflect percentage increases or decreases in the blended cost of water from district supply sources and, beginning in the 2019–20 fiscal year, requires a minimum of 80% of the reserve to be used for water purchases. Current law excepts from this limitation the unexpended balance of any appropriated funds in a capital improvement project construction account established to pay the cost of a project or projects under construction. This bill would repeal this reserve fund authorization and would make conforming changes.
