General Manager's Report on Activities, Projects and Programs (Item 7).

General Manager Stone reported on the following:

He updated the Board on SCV Water's first Water Academy that took place this past month. He stated there were four sessions throughout the month of March 2023 with a graduation held at the last meeting which was held on April 1, 2023. He reported that the staff of presenters covered many facets of our activities at the Agency and thanked staff for all their efforts and hard work in putting the first Water Academy together. He also thanked the Board members who were able to attend and the Board President Gary Martin and Director Cooper for passing out graduation certificates to those who attended.

He then mentioned that he attended the United Water Conservation District Open House and Facilities tour held on March 29, 2023. They toured several facilities and locations including Santa Felicia Dam and Lake Piru Recreation Area, Freeman Diversion and UWCD Recharge

Basins, El Rio Iron and Manganese Water Treatment Plant, and the Oxnard Hueneme Pipeline Pumping through Pipeline and Recharge Basins.

Next he noted that while we wait for the appellate court process in our favorable US Central District Court ruling in SCVWA vs Whittaker to reach some conclusion, we are continuing to operate the Saugus 1 and 2 Wells Perchlorate Treatment Facility, and advance new treatment projects at Well V-201 (adding VOC removal to the existing Perchlorate removal system) and Well V-205 (designing facilities to address both Perchlorate and VOC's). Meanwhile action continues with Whittaker (or its successor) and DTSC. Whittaker's consultants submitted an OU-7 Groundwater Remedial Action Completion / Implementation Report (RACR) to DTSC in February. The RACR is proposing that DTSC deem the groundwater remedial action complete. After review by our own technical consultants, we strongly disagree and have begun communication at DTSC on our position.

Lastly, he advised the Board that on March 24, 2023, the Department of Water Resources increased this year's State Water Project Allocation to 75%. He mentioned that this was not unexpected given the very wet year and high snowpack we've had in the last several months. He announced that the San Luis Reservoir is essentially full and the State Water Project is completely full. In addition, SCV Water's water resources staff were able to evacuate stored water from San Luis into banks and through an exchange agreement with Metropolitan Water District so that we did not lose water to "spill" rules as San Luis filled with current year water.

SUMMARY

The County Sanitation Districts of Los Angeles County is requesting approval and acceptance of a negotiated exchange of property tax revenues resulting from annexation to Santa Clarita Valley Sanitation District Annexation Nos. SCV-1122, SCV-1123, SCV-1124 and SCV-1128.

DISCUSSION

The annexation process requires that a resolution for property tax revenue exchange be adopted by all the affected local agencies before an annexation may be approved. For any jurisdictional change which will result in a special district providing new service not previously provided in an area, the law requires the governing bodies of all local agencies that receive an apportionment of the property tax from the area to determine by resolution the amount of the annual tax increment to be transferred to the special district (Revenue and Taxation Code Section 99.01).

Finance staff has reviewed the calculations and reallocation of taxes as proposed by LAFCO and has not identified any concerns.

RECOMMENDATION

That the Board of Directors adopt the attached Negotiated Tax Exchange Resolutions resulting from annexation to the Santa Clarita Valley Sanitation District Annexation Nos. SCV-1122, SCV-1123, SCV-1124 and SCV-1128.

Tax Sharing Resolutions


Thank you for signing and returning the last joint resolutions that were submitted to your office for tax sharing purposes.

Enclosed, in triplicate, is a Joint Tax Sharing Resolution (resolution) involving your agency and others. The applicant has requested, in writing, annexation of his property into the Santa Clarita Valley Sanitation District (District) in order to receive off-site disposal of sewage. Please see the table below for the annexation and its associated project. The annexation process requires that a resolution for property tax revenue exchange be adopted by all the affected local agencies before an annexation may be approved. For any jurisdictional change which will result in a special district providing new service not previously provided to an area, the law requires the governing bodies of all local agencies that receive an apportionment of the property tax from the area to determine by resolution the amount of the annual tax increment to be transferred to the special district (Revenue and Taxation Code Section 99.01). Please note that by sharing the property tax increment with the District resulting from this annexation, your agency will not lose any existing ad valorem tax revenue it currently receives from the affected territory. Your agency would only be giving up a portion of the revenues it would receive on increased assessed valuation.

Annexation No. Type of Project

SCV-1122 137 proposed single-family homes

Also, attached for the annexation is a copy of the applicable worksheet and map showing the location of the annexation. The worksheet lists the annual tax increment to be exchanged between your agency, other affected taxing entities, and the District. The tax sharing ratios listed in the worksheet were calculated by the County Auditor Controller by specific Tax Rate Area (TRA). For example, if the annexing territory were to lie within two separate TRAs, there would be a worksheet for each TRA. The Los Angeles County Chief Executive Office (CEO) is requiring the District to implement the worksheet for all District annexations in order to increase efficiency for the calculation of property tax sharing ratios.



The resolution is being distributed to all parties for signature in counterpart. Therefore, you will only be receiving a signature page for your agency. Enclosed are three sets of the resolution. One set of the resolution is for your files and the other two sets of the resolution need to be returned to the District. Please execute the two sets of the resolution and return them to the undersigned within 60 days as required by the Government Code. In addition, the County CEO's legal counsel is also requesting that the signature pages be properly executed from all affected agencies. Therefore, please have the Attest line signed by the appropriate person. Upon completion of the annexation process, your office will receive a fully executed copy of the tax sharing resolution for your files.

APPROVING AND ACCEPTING NEGOTIATED EXCHANGE OF PROPERTY TAX REVENUES RESULTING FROM ANNEXATION TO SANTA CLARITA VALLEY SANITATION DISTRICT.

"ANNEXATION NO. 1122"

WHEREAS, pursuant to Section 99 and 99.01 of the Revenue and Taxation Code, prior to the effective date of any jurisdictional change which will result in a special district providing a new service, the governing bodies of all local agencies that receive an apportionment of the property tax from the area must determine the amount of property tax revenues from the annual tax increment to be exchanged between the affected agencies and approve and accept the negotiated exchange of property tax revenues by resolution; and

WHEREAS, the governing bodies of the agencies signatory hereto have made determinations of the amount of property tax revenues from the annual tax increments to be exchanged as a result of the annexation to Santa Clarita Valley Sanitation District entitled *Annexation No. 1122*;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The negotiated exchange of property tax revenues resulting from the annexation of territory to Santa Clarita Valley Sanitation District in the annexation entitled *Annexation No. 1122* is approved and accepted.
- 2. For each fiscal year commencing on and after July 1, 2022, or after the effective date of this jurisdictional change, whichever is later, the County Auditor shall transfer to Santa Clarita Valley Sanitation District a total of 0.9460229 percent of the annual tax increment attributable to the land area encompassed within *Annexation No. 1122* as shown on the attached Worksheet.
- 3. No additional transfer of property tax revenues shall be made from any other tax agencies to Santa Clarita Valley Sanitation District as a result of annexation entitled *Annexation No. 1122*.

WHEREAS, pursuant to Section 99 and 99.01 of the Revenue and Taxation Code, prior to the effective date of any jurisdictional change which will result in a special district providing a new service, the governing bodies of all local agencies that receive an apportionment of the property tax from the area must determine the amount of property tax revenues from the annual tax increment to be exchanged between the affected agencies and approve and accept the negotiated exchange of property tax revenues by resolution; and

WHEREAS, the governing bodies of the agencies signatory hereto have made determinations of the amount of property tax revenues from the annual tax increments to be exchanged as a result of the annexation to Santa Clarita Valley Sanitation District entitled *Annexation No. 1124*;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The negotiated exchange of property tax revenues resulting from the annexation of territory to Santa Clarita Valley Sanitation District in the annexation entitled *Annexation No. 1124* is approved and accepted.
- 2. For each fiscal year commencing on and after July 1, 2022, or after the effective date of this jurisdictional change, whichever is later, the County Auditor shall transfer to Santa Clarita Valley Sanitation District a total of 0.975187 percent of the annual tax increment attributable to the land area encompassed within *Annexation No. 1124* for Tax Rate Area 00219 as shown on the attached Worksheet.

- 3. For each fiscal year commencing on and after July 1, 2022, or after the effective date of this jurisdictional change, whichever is later, the County Auditor shall transfer to Santa Clarita Valley Sanitation District a total of 0.968304 percent of the annual tax increment attributable to the land area encompassed within *Annexation No. 1124* for Tax Rate Area 00224 as shown on the attached Worksheet.
- 4. No additional transfer of property tax revenues shall be made from any other tax agencies to Santa Clarita Valley Sanitation District as a result of annexation entitled *Annexation No. 1124*.
- 5. No transfer of property tax increments from properties within a community redevelopment project, which are legally committed to a Community Redevelopment Agency, shall be made during the period that such tax increment is legally committed for repayment of the redevelopment project costs.
- 6. If at any time after the effective date of this resolution, the calculations used herein to determine initial property tax transfers or the data used to perform those calculations are found to be incorrect thus producing an improper or inaccurate property tax transfer, the property tax transfer shall be recalculated and the corrected transfer shall be implemented for the next fiscal year.

The foregoing resolution was adopted by the Board of Supervisors of the County of Los Angeles, the Board of Directors of Santa Clarita Valley Sanitation District of Los Angeles County, and the governing bodies of Greater Los Angeles County Vector Control District, City of Santa Clarita, Santa Clarita Street Lighting Maintenance District No. 2, Santa Clarita Library, and Santa Clarita Valley Water Agency, signatory hereto.




Tax Sharing Resolutions

Thank you for signing and returning the last joint resolutions that were submitted to your office for tax sharing purposes.

Enclosed, in triplicate, is a Joint Tax Sharing Resolution (resolution) involving your agency and others. The applicant has requested, in writing, annexation of his property into the Santa Clarita Valley Sanitation District (District) in order to receive off-site disposal of sewage. Please see the table below for the annexation and its associated project. The annexation process requires that a resolution for property tax revenue exchange be adopted by all the affected local agencies before an annexation may be approved. For any jurisdictional change which will result in a special district providing new service not previously provided to an area, the law requires the governing bodies of all local agencies that receive an apportionment of the property tax from the area to determine by resolution the amount of the annual tax increment to be transferred to the special district (Revenue and Taxation Code Section 99.01). Please note that by sharing the property tax increment with the District resulting from this annexation, your agency will not lose any existing ad valorem tax revenue it currently receives from the affected territory. Your agency would only be giving up a portion of the revenues it would receive on increased assessed valuation.

The Los Angeles County Chief Executive Office (CEO) is requiring the District to implement the worksheet for all District annexations in order to increase efficiency for the calculation of property tax sharing ratios.

One set of the resolution is for your files and the other two sets of the resolution need to be returned to the District. Please execute the two sets of the resolution and return them to the undersigned within 60 days as required by the Government Code. In addition, the County CEO's legal counsel is also requesting that the signature pages be properly executed from all affected agencies. Therefore, please have the Attest line signed by the appropriate person. Upon completion of the annexation process, your office will receive a fully executed copy of the tax sharing resolution for your files.



SUBJECT: Authorize the Chief Engineer to Execute Water Service Agreements with the

Los Angeles Residential Community and Royce Lily of the Valley LLC

SUMMARY

SCV Water has executed a Financing Agreement with the State Water Resources Control Board (SWRCB) by Resolution No. SCV-245 to consolidate two small community water systems: the Los Angeles Residential Community (LARC), and Royce Lily of the Valley LLC (LOV). The Financing Agreement requires SCV Water to submit an executed Consolidation and Water Service Agreement (Water Service Agreement) with each system and receive written approval from the SWRCB Project Manager prior to disbursement of any grant funds. Staff has prepared a Water Service Agreement with each system in collaboration with the SWRCB, LARC, and LOV. Resolution SCV-245 authorizes the Agency Representative or designee to execute and deliver documents contemplated by the Financing Agreement, including but not limited to the Water Service Agreements. Staff recommends that the Board of Directors authorizes the Chief Engineer to execute the attached Water Service Agreements.

DISCUSSION

<u>Project Scope and Background</u>: LARC and LOV both operate community water systems for their residents. Due to extended drought conditions in Southern California and lack of groundwater recharge in the Bouquet Canyon Creek area, LARC has been unable operate its wells and has been forced to haul water to meet the needs of its residents. LOV's water supply could face similar constraints. LARC and LOV properties are within the existing SCV Water service area. LARC and LOV have formally requested, by respective resolutions, to consolidate with SCV Water via master meter consolidations. SCV Water will construct a new pipeline that will extend over one and three-quarter miles along Bouquet Canyon Road to the LARC and LOV properties and install master meter(s) in front of each property.

The Financing Agreement requires SCV Water to execute a Water Service Agreement with each system. Under the terms of the Water Service Agreements, LARC and LOV must surrender their domestic water supply permits and disconnect their wells from their onsite potable distribution systems at their cost before SCV Water service can begin service. LARC and LOV will continue to own, operate, and maintain their onsite distribution systems after the master meter(s), including necessary backflow prevention devices. SCV Water's only responsibility will be to provide water to the LARC and LOV properties at the master meters.

The Financing Agreement and Water Service Agreements outline the requirement for Final Budget Approval by the SWRCB based on competitive bids. If the successful bid exceeds the authorized grant funds, SCV Water will seek an amendment to the Financing Agreement for additional grant funds to cover the entire cost for eligible portions of the project. The Financing Agreement includes a 15% contingency for change orders during construction. If the

construction change order(s) exceed(s) the grant fund contingency, LARC and LOV shall be responsible for their proportional share of the change order(s).

CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) CONSIDERATIONS

SCV Water adopted the Mitigated Negative Declaration (MND) and Mitigation Monitoring and Reporting Program (MMRP) for the proposed consolidation project to construct the proposed pipeline in Bouquet Canyon Road by Resolution 3158 on March 8, 2017. SCV Water filed the Notice of Determination with the Los Angeles County Clerk's Office and the State Clearinghouse on April 13, 2017. Furthermore, SCV Water staff issued a letter on January 27, 2021 to the SWRCB to document its review and conclusion that providing master meter connections to LOV from the proposed pipeline is covered by the adopted MND.

On April 6, 2023, the Engineering and Operations Committee considered staff's recommendation to authorize the Chief Engineer to execute Water Service Agreements with Los Angeles Residential Community and Royce Lily of the Valley LLC.

STRATEGIC PLAN NEXUS

This project helps meet SCV Water's Strategic Plan Objective "E.1 – Increase focus on forward looking financial information" by pursing grant and loan funds from the SWRCB to fund the eligible portion of the LARC pipeline project."

FINANCIAL CONSIDERATIONS

SCV Water executed a Financing Agreement with the SWRCB for \$3,931,991 in grant funds on behalf of LARC and LOV, pursuant to SCV Water Resolution SCV-245 to consolidate LARC and LOV with SCV Water and to fund a new 8-inch diameter pipeline sized to serve LARC and LOV. SCV Water has opted to upsize the pipeline to a 12-inch diameter to allow other existing developed areas (e.g., ranches, businesses) that currently rely on private wells to connect to the pipeline, subject to payment of connection fees and construction of new services. SCV Water has budgeted \$1,500,000 from the Agency's FY 2022/23 Capital Improvement Program for the marginal cost to upsize the pipeline. The Financing Agreement requires that SCV Water bid the project in such a way to demonstrate the construction costs for the 8-inch pipeline and the 12-inch pipeline as a basis for Final Budget Approval. Costs for the pipeline upsize will be recovered in part by payment of facility capacity fees from new service connections requested by existing developments along the pipeline route.

RECOMMENDATION

The Engineering and Operations Committee recommends that the Board of Directors authorize the Chief Engineer to execute the respective Consolidation and Water Service Agreements (Attachments A and B) with Los Angeles Residential Community and Royce Lily of the Valley LLC.

CONSOLIDATION AND WATER SERVICE AGREEMENT BETWEEN

LOS ANGELES RESIDENTIAL COMMUNITY FOUNDATION

AND

SANTA CLARITA VALLEY WATER AGENCY

This Agreement ("Agreement") is made and entered into, by and between the SANTA CLARITA VALLEY WATER AGENCY ("SCV WATER"), which will at times operate through its retail Santa Clarita Water Division ("SCV WATER – SCWD"), and the LOS ANGELES RESIDENTIAL COMMUNITY FOUNDATION ("LARC"). SCV WATER and LARC are hereinafter sometimes referred to as "Party" or collectively as "Parties."

RECITALS

- A. The Santa Clarita Valley Water Agency ("SCV WATER") was created January 1, 2018 by an act of the State Legislature (SB 634) that formally merged two water agencies: Castaic Lake Water Agency, which includes its Santa Clarita Water Division, and the Newhall County Water District. SB 634 also mandated that the Valencia Water Company, a private retail water company, be dissolved and incorporated into SCV WATER, and this occurred on January 22, 2018. SCV WATER serves a population of 289,000 through 73,500 retail water connections, covering approximately 195 square miles in the Santa Clarita Valley;
- B. SCV WATER SCWD is one of three retail water divisions within SCV WATER and is governed by the SCV WATER Board of Directors;
- C. LARC is a California nonprofit corporation, governed by a Board of Directors, and the owner of the property commonly referred to as the LARC Ranch;
- D. LARC, which provides long-term health care facility services, currently provides water service to its residents within LARC's community service area ("Service Area"), through various facilities owned by LARC, which are located in Los Angeles County, California, and as described in Exhibit A attached hereto and incorporated herein by reference (the "Property"). The Property is operated by LARC. The source of potable water for the Service Area is groundwater from one or more wells on the Property;
- E. SCV WATER, as a public agency and on behalf of LARC, is eligible to apply for a grant from the State Water Resources Control Board ("SWRCB") for grant funding which provides grants for small community drinking water system infrastructure improvements;

- F. At the request of, and in order to promote and protect the health and safety of the residents of the Service Area, SCV WATER has submitted an application for a Grant ("Grant") with the SWRCB;
- G. SCV WATER is intended to be the recipient of Grant funds to complete a pipeline construction project to LARC Ranch and Lily of the Valley Service Area which includes engineering design for the selected project alternative to, among other goals, meet safe drinking water standards for service to those properties ("Project");
- H. If the Project meets with the approval of SWRCB, SCV WATER, and LARC, and if Grant funds are available to construct infrastructure facilities ("Construction Project") (which Project is generally described in Exhibit B to this Agreement) wherein the SCV WATER, through SCV WATER SCWD, would provide water service to LARC's residents, then an agreement is required between SCV WATER and LARC that identifies the responsibilities and obligations of the Parties regarding the use of the Grant funds for the Construction Project, and the provision of water service to LARC's residents; and
- I. The Parties desire to enter into such an agreement.

AGREEMENT

NOW, THEREFORE the Parties hereby agree as follows:

- 1. <u>Incorporation of Recitals.</u> All of the above recitals are incorporated herein by reference and agreed upon by the Parties.
- 2. Grant. SCV WATER is authorized to act on behalf of LARC regarding the Grant and to receive and use all of the Grant for the Project and, to the extent available, to complete the Construction Project if such Construction Project is approved by SWRCB and the Parties, subject to approval by SCV WATER's Board of Directors and execution of a Drinking Water Construction Grant and Loan Agreement, Project No. 1910017-001C, with the SWRCB ("SWRCB Agreement"). SCV WATER shall use reasonable efforts to obtain the Grant funds necessary for the Project and the Construction Project; however, the decision to approve the Grant is made by the SWRCB and not SCV WATER.
- 3. <u>Construction Project.</u> Provided a SWRCB Agreement is executed, SCV WATER shall build and complete the Construction Project, and SCV WATER SCWD will provide potable water to the LARC Property upon the following terms and conditions, and as may otherwise be set forth in this Agreement or agreed upon in writing by the Parties.

- a. Service to LARC's residents shall be conditioned upon such Board of Directors' approval and such Board of Directors' application for water service to SCV WATER's retail division, SCV WATER SCWD, and shall be subject to and based upon the same rates, charges, terms, conditions, rules, regulations, and policies that are applicable to SCV WATER SCWD customers under similar circumstances, as such may be modified or amended from time to time.
- b. All costs related to (i) construction of the facilities that constitute the Construction Project, which facilities shall be owned by SCV WATER, and (ii) connections for service shall be paid for from Grant funds to the extent such costs are eligible for reimbursements as determined by the SWRCB. SCV WATER has authorized payment for certain ineligible costs for the Project, which costs are generally described in Exhibit C to this Agreement, and LARC shall not be responsible or liable to pay any portion of those ineligible costs. If costs related to construction of facilities and connections for service exceed Grant funds and/or funds authorized by the SCV WATER's Board of Directors, LARC shall be a responsible party for such costs subject to the following (W) after execution of this Agreement, SCV Water shall obtain an updated bid from a licensed contractor for the construction of the entire Construction Project, which shall include a 15% contingency amount (the "Updated Bid"); (X) in the event that the costs of the entire Construction Project per the Updated Bid exceed Grant Funds, SCV Water shall seek an amendment to the SWRCB Agreement to cover the entirety of eligible costs of the entire Construction Project; (Y) if the amendment is not approved, LARC and SCV WATER shall meet and confer in good faith in an attempt to reach a mutually agreeable costsharing solution; and (Z) if a mutually agreeable cost-sharing solution is not achieved, either Party may elect to cancel this Agreement. Except as otherwise provided in this Agreement or SCV WATER or SCV WATER - SCWD rules, regulations, or policies as may be amended from time to time, SCV WATER shall provide operation and maintenance with respect to SCV WATER facilities.
- c. Upon completion of the Construction Project and SCV WATER SCWD providing notice to LARC that it is able to provide water service to the LARC Property with the Construction Project facilities (the "Ready to Serve Notice"), LARC shall cease providing domestic water service to its residents and shall surrender its domestic water supply permits/approvals and cease to exist as a domestic water system for the purpose of providing water service to its residents.
- d. All facility capacity fees, including but not limited to the SCV WATER Regional Facility Capacity Fee and SCV WATER SCWD's Distribution Facility Capacity Fee (as generally described in Exhibit D to this Agreement) shall be paid for by Grant funds. To the extent Grant funds are unavailable for such fees, LARC shall be responsible for those fees subject to the following (i)

in the event such fees exceed Grant funds, SCV WATER shall seek an amendment to the SWRCB Agreement to cover the entirety of eligible Project costs prior to commencement of the Construction Project: (ii) if the amendment is not approved, LARC and SCV WATER shall meet and confer in good faith in an attempt to reach a mutually agreeable cost-sharing solution; and (iii) if a mutually agreeable cost-sharing solution is not achieved to cover such fees, either Party may elect to cancel this Agreement.

- 4. <u>Estimated Project Completion Schedule.</u> Provided the SWRCB Agreement is executed, the Parties estimate an approximately one- and one-half year preliminary construction schedule from the date of Grant approval as set forth in the SWRCB Agreement.
- 5. LARC Indemnification. LARC shall release, indemnify, and hold SCV WATER and SCV WATER SCWD harmless from any claims by LARC, its residents, or their guardians, next of kin, or other individuals with standing to sue on behalf of a LARC resident, damages or liabilities of any sort whatsoever that may exist prior to the execution of this Agreement, and/or arising out of or in any way connected with the Grant not being approved by SWRCB in the amount necessary to carry out the Project or the Construction Project, or if SCV WATER determines that sufficient funds are not received to construct the Project, or for any matter brought by LARC against SCV WATER or SCV WATER SCWD and which arise out of this Agreement or its application, excluding any gross negligence or willful misconduct by SCV WATER. Notwithstanding the foregoing, this paragraph is not intended to waive and does not waive other claims not excluded above that LARC may have against SCV WATER and SCV WATER SCWD for their breach of this Agreement.
- LARC Responsibility for Construction Cost Overruns. If after the Construction 6. Project is commenced SCV WATER receives a legally valid charge from the contractor carrying out the Construction Project ("Contractor") that exceeds the Updated Bid and the 15% contingency amount therein (a "Cost Overrun"), SCV WATER shall provide LARC with prompt notice of the Cost Overrun. SCV WATER shall use reasonable efforts to pay the Cost Overrun by seeking funds from SWRCB, including but not limited to amendment to the SWRCB Agreement for additional Grant funds or funds from the Drinking Water State Revolving Fund and Proposition 68. If such additional funding for the Cost Overrun is not available, then LARC shall only be responsible for its proportional share of the Cost Overrun based on the formula set forth in Exhibit C, an allocation of 48.39% to LARC and an allocation of 51.61% to Lily of the Valley. LARC shall not be responsible for Lily of the Valley's allocation of the Cost Overrun, and Lily of the Valley shall not be responsible for LARC's allocation of the Cost Overrun. LARC's residents have paid the SCV WATER Regional Facility Capacity Fee and seek to be reimbursed from Grant funds and/or SCV WATER. The Parties intend that SCV WATER – SCWD's Distribution Facility Capacity Fee be paid for with Grant funds. If any such SCV WATER or SCV WATER – SCWD Facility Capacity Fees are not reimbursed and/or paid with Grant funds, LARC is responsible for payment and will have the option to meet and

- confer with SCV WATER in an attempt to reach a mutually agreeable solution.
- 7. Consolidation. Upon completion of the Project, connection of the LARC Service Area to the SCV WATER SCWD's water service and LARC's receipt of the Ready to Serve Notice, (a) LARC agrees to surrender its domestic water supply permit to SWRCB, (b) LARC will cease operation as a purveyor of domestic water to its residents, and (c) LARC shall take other actions as required under this Agreement.
- 8. Onsite Improvements. In connecting the SCV WATER SCWD's water service to LARC's Property, SCV WATER SCWD will provide and install a master meter in front of LARC's Property, an onsite booster pump station downstream of the master meter, a backflow prevention device at the meter, and piping within public rights of way and onsite to allow connection of the new water system to the LARC Property ("Onsite Improvements"). These Onsite Improvements will be paid for by SCV WATER with Grant funds, but only to the extent such Grant funds are available. If Grant funds are not available, or are insufficient, LARC will have the option to meet and confer with SCV WATER in an attempt to reach a mutually agreeable solution.
- 9. Operations. Once the Onsite Improvements have been constructed and installed and SCV WATER SCWD's water service has been connected to the LARC Property, LARC shall own and be responsible for the operation and maintenance of the Onsite Improvements downstream from the master meter in accordance with applicable laws and regulations, including the onsite booster pump station, and any necessary backflow device testing/repairs, as well as existing distribution and storage facilities. Notwithstanding the above, the master meter will be owned and maintained by SCV WATER. Disconnection of LARC Property from the existing LARC water supply system must be witnessed by SCV WATER staff.
- 10. Plan Review. The Construction Project to be installed shall be constructed in substantial compliance with the detailed plans and specifications prepared by SCV WATER or its consultants, which shall be subject to review by a designated representative from LARC upon request. The onsite booster pump station and associated improvements shall be constructed in substantial compliance with the detailed plans and specifications prepared by LARC or its consultants, and in accordance with applicable regulations and standards including, but not limited to California Plumbing Code, California Water Code and Los Angeles County Building Permits. LARC shall have the right to comment and provide recommendations to the scope of the Construction Project and the specifications for the purpose of keeping any and all costs within the amount of anticipated Grant funds to be received. All SCV WATER infrastructure and related plans and specifications shall be considered confidential and shall not be disclosed by LARC to any third person without the prior written approval of SCV WATER.
 - a. <u>Existing Wells.</u> Upon completion of the Construction Project and connection of SCV WATER's water service to LARC Property, LARC shall not be allowed to use its existing water well(s) for domestic water supply or operate as

a domestic water system and, as part of the Construction Project, the Parties anticipate the existing LARC well(s) will be properly disconnected with appropriate backflow prevention devices to be approved by SCV WATER or abandoned and destroyed in accordance with state and local requirements. LARC will be responsible for all costs associated with disconnecting, abandoning, or destroying existing well(s); these costs are not included in the Grant funds or funds which SCV WATER has authorized. LARC must disconnect existing well(s) from the onsite distribution system before water service can begin AND NO LATER THAN the CONSTRUCTION COMPLETION DATE established in the SWRCB Agreement, including any amendments.

- 11. <u>Binding on Successors.</u> This Agreement shall be binding upon LARC, its grantees, successors, assigns, and lessees.
- 12. <u>Notices.</u> Any and all notices or other matters required or permitted by this Agreement or by law to be served on, given to, or delivered to either party by the other party to this Agreement shall be in writing and shall be deemed duly served, given, or delivered when personally delivered to the party to whom it is directed, or, in lieu of personal service when deposited in the United States mail, first-class postage prepaid, or delivered via email, addressed to:

- 13. <u>Amendments.</u> This Agreement may only be amended by written agreement, executed by the Parties.
- 14. <u>Complete Agreement.</u> This Agreement contains the complete agreement of the Parties in regards to the subject matter of this Agreement, and there are no other agreements, oral or written, except as are included within the terms of this Agreement.
- 15. <u>Severability.</u> Should any provision of this Agreement be found to be void or unenforceable, it shall be severable from the rest of the Agreement, and the remaining

terms shall be enforced as if the unenforceable term had not existed.

- 16. <u>Mutual Drafting.</u> This Agreement shall be deemed to have been drafted by both Parties, with each having equal say and status.
- 17. <u>Authority To Execute.</u> Each Party warrants and represents that it has the authority to execute this Agreement, and that the execution was duly authorized by the Party on whose behalf it is executed.
- 18. Term. In the event the Construction Project is not undertaken or completed within three (3) years from the execution of this Agreement, or in the event of material changes in circumstances which, in the opinion of either SCV WATER or LARC, are such that SCV WATER SCWD cannot reasonably provide services to LARC Property, SCV WATER may terminate its obligation(s) under this Agreement. Prior to the termination, the Parties will enter into good-faith negotiations and endeavor to reach mutually agreeable terms in an effort to extend this Agreement or reach some other mutually agreeable arrangement. In the event a Party reasonably believes that the other Party has failed to perform all of its obligations hereunder, the other Party may, after 60 days written notice to cure, unilaterally declare this Agreement terminated. In the event of termination, obligations to indemnify as set forth in section 4 shall survive termination and will continue for such period of time as the statues of limitations have not expired on any possible or pending claims.
- 19. Restoration if Terminated. LARC shall be entitled, within 180 days following the end of the Term, to remove any incomplete Project construction items on its Property, which shall be done at SCV WATER's expense, but only if and to the extent Grant funds exist and are available for such purpose. SCV WATER, SCV WATER – SCWD, and its agents, consultants, and representatives shall have access at all reasonable times to the Property and the Project for purposes of such removal. SCV WATER is responsible to repair any and all damage caused by the removal of the Project, but only if and to the extent Grant funds exist and are available for such purpose. If the Agreement is terminated and SCV WATER has not yet provided services to LARC, SCV WATER shall restore any existing LARC facilities to the condition which existed at the time this Agreement is executed, if any facilities were altered or destroyed from their current function of providing water to the LARC residents, but only if and to the extent Grant funds exist and are available for such purpose. All such removals and restoration shall be accomplished in a good and workmanlike manner and so as not to cause any damage to the Property.
- 20. <u>Insufficient Funds.</u> As also indicated elsewhere in this Agreement, in the event insufficient Grant funds and/or SCV WATER authorized funds are available to complete the Construction Project, LARC shall be responsible for such costs, and both SCV WATER and LARC shall meet and confer in good faith in an effort to reach a mutually satisfactory agreement. In the event a mutually satisfactory agreement cannot be reached, either SCV WATER or LARC may cancel this agreement; however, the obligations to indemnify as set forth in section 4 shall survive termination and will

- continue for such period of time as the statutes of limitations have not expired on any possible or pending claims. LARC acknowledges that this Project and Construction Project is contingent upon execution of the SWRCB Agreement.
- 21. <u>Time is of the Essence.</u> Time is of the essence in the performance of the activities contemplated by this Agreement.
- 22. <u>Limitations.</u> Except as specified in this Agreement, nothing in this Agreement shall be construed as giving either Party the right or ability to bind the other or create any joint liability as regards the activities under this Agreement.
- 23. No Assignment of Rights. No rights which either Party has under this Agreement may be assigned to any other person, persons, corporation, or entity without prior written approval of the other Party. Any such transfer or assignment made in violation of this Section shall be void. The terms of this Agreement shall inure to the benefit of the successors to the Parties.
- 24. <u>California Law.</u> All provisions of this Agreement and rights and obligations of the Parties hereto shall be interpreted and construed according to the laws of the State of California.
- 25. <u>Captions Merely Descriptive.</u> Each of the labels, descriptions or captions attached to and accompanying each of the articles and or subparts contained herein is merely illustrative and used for the convenience and reference of the parties, and is not intended to nor creates and additional rights, duties or obligations due or owed to either party to this Agreement.
- 26. <u>Additional Documents; Cooperation.</u> The Parties agree upon request to execute, acknowledge, and deliver all additional papers and documents reasonably necessary to carry out the intent of this Agreement. The Parties further agree to cooperate with one another to effectuate the terms of this Agreement and the intent of the Parties hereto.
- 27. Easements. SCV WATER's obligation to construct the Construction Project is expressly conditioned upon, in addition to any and all other limitations contained within this Agreement, the receipt by SCV WATER, at no cost to the SCV WATER, of any and all easements deemed reasonably necessary by SCV WATER for the Construction Project or any part thereof. SCV WATER will obtain a temporary construction easement, in the form of an access license agreement, from LARC as required for construction of the onsite booster pump station and associated piping.




Exhibit B: Project Description and Maps

Funding for the project will be used to consolidate two small water systems into SCV Water. The project will provide a reliable water supply to Lily of the Valley (LOV) and the Los Angeles Residential Community (LARC).

The project will construct a new 12-inch ductile iron pipeline that connects to the nearest SCV Water pipeline at Shadow Valley Lane and extends approximately 9,600 feet to the frontage of the LARC's property at 29890 Bouquet Canyon Road.

For LARC's connection the project will construct a new 4-inch meter, onsite backflow preventer, and onsite pump station. The onsite pump station will be owned, operated, and maintained by LARC.

For LOV's connection, the project will construct two new 4-inch master meters with associated piping and appurtenances.





Eligible Costs (Grant Funded)

Eligible costs include costs for 9,600 feet of 8-inch ductile iron pipeline with all fire hydrants and other appurtenances as shown on approved 8-inch pipeline plans. Eligible costs will be based on the selected contractor bid price for the 8-inch pipeline.

For LARC's connection, costs include a new 4-inch master meter; and onsite pump station (as shown on pump station plans). SCV Water Facility Capacity fees are included as eligible costs.

For LOV's connection, costs include two new 4-inch master meters, including service laterals. SCV Water Facility Capacity Fees are included as eligible costs.

If bid prices for the eligible project costs exceed grant funding, then SCV Water will request an amendment to the SWRCB Agreement to cover the entirety of eligible cost items for the project in accordance with the SWRCB Agreement Section B.5 Line-Item Adjustments.

If the amendment to the SWRCB Agreement is not sufficient to cover the entirety of eligible Project cost overruns, including change orders during construction, then SCV Water will meet and confer in good faith with LARC and LOV for approval and to apportion the costs for the cost overruns based according to the following formula:

- LARC's allocation is 48.39%
- LOV's allocation is 51.61%

Cost overruns for onsite construction for LARC would be excluded from cost sharing and would be the sole responsibility of LARC.

Ineligible Costs

SCV Water - Ineligible costs are the marginal cost to upsize the pipeline from 8-inch ductile iron pipe to 12-inch ductile iron pipe. The marginal construction costs will be determined by the difference between the selected construction contractor's bid price for the 12-inch pipeline and the 8-inch pipeline.

Lily of the Valley – Ineligible costs are the onsite improvements by Lily of the Valley that will include installation of a backflow preventer after each 4-inch master meter and onsite (customer side) piping to connect to the existing onsite distribution system. Lily of the Valley will be responsible for disconnecting the existing water wells and tanks from the onsite potable water distribution system.

Los Angeles Residential Community – Ineligible costs will include disconnecting the existing water wells from the onsite potable water distribution system.






CONSOLIDATION AND WATER SERVICE AGREEMENT BETWEEN

ROYCE LILY OF THE VALLEY LLC dba Lily of the Valley Mobile Village

AND

SANTA CLARITA VALLEY WATER AGENCY

This Agreement ("Agreement") is made and entered into, by and between the SANTA CLARITA VALLEY WATER AGENCY ("SCV WATER"), which will at times operate through its retail Santa Clarita Water Division ("SCV WATER – SCWD"), and the Royce Lily of the Valley LLC dba Lily of the Valley ("Lily of the Valley" or "LOV"). SCV WATER and LOV are hereinafter sometimes referred to as "Party" or collectively as "Parties."

RECITALS

- A. The Santa Clarita Valley Water Agency ("SCV WATER") was created January 1, 2018 by an act of the State Legislature (SB 634) that formally merged two water agencies: Castaic Lake Water Agency, which includes its Santa Clarita Water Division, and the Newhall County Water District. SB 634 also mandated that the Valencia Water Company, a private retail water company, be dissolved and incorporated into SCV WATER, and this occurred on January 22, 2018. SCV WATER serves a population of 289,000 through 73,500 retail water connections, covering approximately 195 square miles in the Santa Clarita Valley;
- B. SCV WATER SCWD is one of three retail water divisions within SCV WATER and is governed by the SCV WATER Board of Directors;
- C. Lily of the Valley is a Delaware Limited Liability Company, managed by its Member, and the owner of the property commonly referred to as the Lily of the Valley;
- D. Lily of the Valley currently provides water service to its residents within Lily of the Valley's community service area ("Service Area"), through various facilities owned by Lily of the Valley, which are located in Los Angeles County, California, and as generally described in Exhibit A (Property Parcel Maps Lily of the Valley) attached hereto and incorporated herein by reference (the "Property"). The Property is operated by Lily of the Valley. The source of potable water for the Service Area is groundwater from one or more wells owned by Lily of the Valley;
- E. SCV WATER, as a public agency and on behalf of Lily of the Valley, is eligible to apply for a grant from the State Water Resources Control Board ("SWRCB") for grant funding, which provides grants for small community drinking water system infrastructure improvements;

- F. At the request of, and in order to promote and protect the health and safety of the residents of the Service Area, SCV WATER has submitted an application for a Grant ("Grant") with the SWRCB;
- G. SCV WATER is intended to be the recipient of Grant funds to complete a pipeline construction project to LARC Ranch and the Lily of the Valley Service Area, which includes engineering design for the selected project alternative to, among other goals, meet safe drinking water standards for service to those properties ("Project");
- H. If the Project meets with the approval of SWRCB, SCV WATER, and LOV, and if Grant funds are available to construct infrastructure facilities ("Construction Project") (which Project is generally described in Exhibit B to this Agreement) wherein the SCV WATER, through SCV WATER SCWD, would provide water service to Lily of the Valley's residents, then an agreement is required between SCV WATER and Lily of the Valley that identifies the responsibilities and obligations of the Parties regarding the use of the Grant funds for the Construction Project, and the provision of water service to Lily of the Valley's residents; and
- I. The Parties desire to enter into such an agreement.

AGREEMENT

NOW, THEREFORE the Parties hereby agree as follows:

- 1. <u>Incorporation of Recitals.</u> All of the above recitals are incorporated herein by reference and agreed upon by the Parties.
- 2. Grant. SCV WATER is authorized to act on behalf of Lily of the Valley regarding the Grant and to receive and use all of the Grant for the Project and, to the extent available, to complete the Construction Project if such Construction Project is approved by SWRCB and the Parties, subject to approval by SCV WATER's Board of Directors and execution of a Drinking Water Construction Grant and Loan Agreement, Project No. 1910017-001C, with the SWRCB ("SWRCB Agreement"). SCV WATER shall use reasonable efforts to obtain the Grant funds necessary for the Project and the Construction Project; however, the decision to approve the Grant is made by the SWRCB and not SCV WATER.
- 3. <u>Construction Project.</u> Provided a SWRCB Agreement is executed, SCV WATER shall build and complete the Construction Project, and SCV WATER SCWD will provide potable water to the Lily of the Valley Property upon the following terms and conditions, and as may otherwise be set forth in this Agreement or agreed upon in writing by the Parties.

- a. Service to Lily of the Valley's residents shall be conditioned upon approval from its Member and such Member's application for water service to SCV WATER's retail division, SCV WATER SCWD, and shall be subject to and based upon the same rates, charges, terms, conditions, rules, regulations, and policies that are applicable to SCV WATER SCWD residential customers under similar circumstances, as such may be modified or amended from time to time.
- b. All costs related to (i) construction of the facilities that constitute the Construction Project, which facilities shall be owned by SCV WATER, and (ii) connections for service shall be paid for from Grant funds to the extent such costs are eligible for reimbursements as determined by the SWRCB. SCV WATER has authorized payment for certain ineligible costs for the Project, which costs are generally described in Exhibit C to this Agreement, and LOV shall not be responsible or liable to pay any portion of those ineligible costs. If costs related to construction of facilities and connections for service exceed Grant funds and/or funds authorized by the SCV WATER's Board of Directors, Lily of the Valley shall be a responsible party for such costs subject to the following—(1) after execution of this Agreement, SCV Water shall obtain a updated bid from a licensed contractor for the construction of the entire Construction Project, which shall include a 15% contingency amount (the "Updated Bid"); (2) in the event that the costs of the entire Construction Project per the Updated Bid exceed Grant funds, SCV Water shall seek an amendment to the SWRCB Agreement to cover the entirety of eligible costs of the entire Construction Project; (3) if the amendment is not approved, LOV and SCV WATER shall meet and confer in good faith in an attempt to reach a mutually agreeable cost-sharing solution; and (4) if a mutually agreeable costsharing solution is not achieved, either Party may elect to cancel this Agreement. Except as otherwise provided in this Agreement or SCV WATER or SCV WATER – SCWD rules, regulations, or policies as may be amended from time to time, SCV WATER shall provide operation and maintenance with respect to SCV WATER facilities.
- c. Upon completion of the Construction Project and SCV WATER SCWD providing notice to LOV that it is able to provide water service to the Lily of the Valley Property with the Construction Project facilities ("the "Ready to Serve Notice"), Lily of the Valley shall cease providing domestic water service to its residents and shall surrender its domestic water supply permits/approvals and cease to exist as a domestic water system for the purpose of providing water service to its residents.
- d. All facility capacity fees, including but not limited to the SCV WATER Regional Facility Capacity Fee and SCV WATER SCWD's Distribution Facility Capacity Fee (as generally described in Exhibit D to this Agreement) shall be paid for by Grant funds. To the extent Grant funds are unavailable for such fees, Lily of the Valley shall be responsible for those fees subject to the

following—(i) in the event such fees exceed Grant funds, SCV Water shall seek an amendment to the SWRCB Agreement to cover the entirety of eligible Project costs prior to commencement of the Construction Project; (ii) if the amendment is not approved, LOV and SCV WATER shall meet and confer in good faith in an attempt to reach a mutually agreeable cost-sharing solution; an d(iii) if a mutually agreeable cost-sharing solution is not achieved to cover such fees, either Party may elect to cancel this Agreement.

- 4. <u>Estimated Project Completion Schedule.</u> Provided the SWRCB Agreement is executed, the Parties estimate an approximately one and one-half year preliminary construction schedule from the date of Grant approval as set forth in the SWRCB Agreement.
- 5. <u>Lily of the Valley Indemnification.</u> Lily of the Valley shall release, indemnify, and hold SCV WATER and SCV WATER SCWD harmless from any claims by Lily of the Valley, its managers, members, officers, directors, employees, and agents for damages or liabilities of any sort whatsoever that may exist prior to the execution of this Agreement, and/or arising out of or in any way connected with the Grant not being approved by SWRCB in the amount necessary to carry out the Project or the Construction Project, or if SCV WATER determines that sufficient funds are not received to construct the Project, or for any matter brought by Lily of the Valley against SCV WATER or SCV WATER –SCWD and which arise out of this Agreement or its application, excluding any gross negligence or willful misconduct by SCV WATER. Notwithstanding the foregoing, this paragraph is not intended to waive and does not waive other claims not excluded above that Lily of the Valley may have against SCV WATER and SCV WATER SCWD for their breach of this Agreement.
- 6. Lily of the Valley Responsibility for Construction Cost Overruns. If after the Construction Project is commenced SCV Water receives a legally valid charge from the contractor carrying out the Construction Project ("Contractor") that exceeds the Updated Bid and the 15% contingency amount therein (a "Cost Overrun"), SCV Water shall provide LOV with prompt notice of the Cost Overrun. SCV Water shall use reasonable efforts to pay the Cost Overrun by seeking funds from SWRCB, including but not limited to amendment to the SWRCB Agreement for additional Grant funds or funds from the Drinking Water State Revolving Fund and Proposition 68. If such additional funding for the Cost Overrun is not available, then LOV shall only be responsible for its proportional share of the Cost Overrun based on the formula set forth in Exhibit C, an allocation of 51.61% to LOV and an allocation of 48.39% to LARC. LOV shall not be responsible for LARC's allocation of the Cost Overrun, and LARC shall not be responsible for LOV's allocation of the Cost Overrun.
- 7. <u>Consolidation.</u> Upon completion of the Project, connection of the Lily of the Valley Service Area to the SCV WATER SCWD's water service and LOV's receipt of the Ready to Serve Notice, (a) Lily of the Valley agrees to surrender its domestic water supply permit to SWRCB, (b) Lily of the Valley will cease operation as a purveyor of

- domestic water to its residents, and (c) Lily of the Valley shall take other actions as required under this Agreement.
- Onsite Improvements. In connecting the SCV WATER SCWD's water service to 8. Lily of the Valley's Property, SCV WATER – SCWD will provide and install two master meters in front of the Lily of the Valley Property, the costs of which are included in the Construction Project. Lily of the Valley must provide and install a backflow prevention device immediately downstream of each meter and piping within public rights of way and onsite to allow connection of the new water system to the Lily of the Valley distribution system and shall be responsible for making the final connection with SCV WATER – SCWD ("Onsite Improvements"). Lily of the Valley shall construct all Onsite Improvements in accordance with applicable regulations and standards, including, but not limited to the California Plumbing Code, California Water Code, and Senate Bill-7 (SB-7). These Onsite Improvements are not included in the Construction Project and will be paid for by Lily of the Valley. The Onsite Improvements, including disconnection of existing wells and tanks from the distribution system as noted in Section 10. a., Existing Wells and Tanks, must be completed by Lily of the Valley before water service can begin AND NO LATER THAN the CONSTRUCTION COMPLETION DATE established in the SWRCB Agreement, including any amendments.
- 9. Operations. Once the Onsite Improvements have been constructed and installed and SCV WATER SCWD's water service has been connected to the Lily of the Valley Property, Lily of the Valley shall own and be responsible for the operation and maintenance of the Onsite Improvements downstream from the master meters, including any necessary backflow device testing/repairs as well as existing components necessary for distribution (e.g., private hydrants, sub-meters). Notwithstanding the above, the master meters will be owned and maintained by SCV WATER. Disconnection of Lily of the Valley Property from the existing Lily of the Valley water supply and storage system must be witnessed by SCV WATER staff.
- 10. Plan Review. The Construction Project to be installed shall be constructed in substantial compliance with the detailed plans and specifications prepared by SCV WATER or its consultants, which shall be subject to review by a designated representative from Lily of the Valley upon request. Lily of the Valley shall have the right to comment and provide recommendations to the scope of the Construction Project and the specifications for the purpose of keeping any and all costs within the amount of anticipated Grant funds to be received. All SCV WATER infrastructure and related plans and specifications shall be considered confidential and shall not be disclosed by Lily of the Valley to any third person without the prior written approval of SCV WATER.
 - a. Existing Wells and Tanks. Upon completion of the Construction Project and connection of SCV WATER's water service to Lily of the Valley Property, Lily of the Valley shall not be allowed to use its existing water well(s) for domestic water supply or operate as a domestic water system for its residents,

and, as part of the Construction Project, the Parties anticipate the existing Lily of the Valley well(s) and tanks will be properly disconnected with appropriate backflow prevention devices to be approved by SCV WATER. Lily of the Valley will be responsible for all costs associated with disconnecting existing well(s) and tanks; these costs are not included in the Grant funds or funds which SCV Water has authorized. Disconnection of existing well(s) and tanks from the onsite distribution system must be completed by Lily of the Valley before water service can begin AND NO LATER THAN the CONSTRUCTION COMPLETION DATE established in the SWRCB Agreement, including any amendments, as noted in Section 8 Onsite Improvements.

- 11. <u>Binding on Successors.</u> This Agreement shall be binding upon Lily of the Valley, its grantees, successors, assigns, and lessees.
- 12. Notices. Any and all notices or other matters required or permitted by this Agreement or by law to be served on, given to, or delivered to either party by the other party to this Agreement shall be in writing and shall be deemed duly served, given, or delivered when personally delivered to the party to whom it is directed, or, in lieu of personal service when deposited in the United States mail, first-class postage prepaid, or delivered via email, addressed to:

- 13. <u>Amendments.</u> This Agreement may only be amended by written agreement, executed by the Parties.
- 14. <u>Complete Agreement.</u> This Agreement contains the complete agreement of the Parties in regards to the subject matter of this Agreement, and there are no other agreements, oral or written, except as are included within the terms of this Agreement.
- 15. <u>Severability.</u> Should any provision of this Agreement be found to be void or unenforceable, it shall be severable from the rest of the Agreement, and the remaining terms shall be enforced as if the unenforceable term had not existed.
- 16. <u>Mutual Drafting.</u> This Agreement shall be deemed to have been drafted by both Parties, with each having equal say and status.
- 17. <u>Authority To Execute.</u> Each Party warrants and represents that it has the authority to execute this Agreement, and that the execution was duly authorized by the Party on whose behalf it is executed.
- 18. Term. In the event the Construction Project is not undertaken or completed within three (3) years from the execution of this Agreement, or in the event of material changes in circumstances which, in the opinion of either SCV WATER or Lily of the Valley, are such that SCV WATER SCWD cannot reasonably provide services to Lily of the Valley Property, SCV WATER may terminate its obligation(s) under this Agreement. Prior to the termination, the Parties will enter into good-faith negotiations and endeavor to reach mutually agreeable terms in an effort to extend this Agreement or reach some other mutually agreeable arrangement. In the event a Party reasonably believes that the other Party has failed to perform all of its obligations hereunder, the other Party may, after 60 days written notice to cure, unilaterally declare this Agreement terminated. In the event of termination, obligations to indemnify as set forth in section 5 shall survive termination and will continue for such period of time as the statues of limitations have not expired on any possible or pending claims.
- 19. Cancellation of the Agreement Pursuant to Section 3. In the event that a Party elects to cancel the Agreement pursuant to Section 3, the obligations to indemnify as set forth in section 5 shall survive termination and will continue for such period of time as the statutes of limitations have not expired on any possible or pending claims. Further, Lily of the Valley acknowledges that this Project and Construction Project is contingent upon execution of the SWRCB Agreement. Lily of the Valley acknowledges that if it chooses to cancel this Agreement for failure to agree on Project costs, the SWRCB Agreement shall be amended to exclude Lily of the Valley from being eligible for Grant funds thereunder, but construction of the Project pipeline to LARC Ranch shall proceed. If Lily of the Valley subsequently seeks to connect to the Project pipeline, it would be responsible for all necessary infrastructure and connection fees, including but not limited to capacity fees, service laterals, and meters.

- 20. <u>Time is of the Essence</u>. Time is of the essence in the performance of the activities contemplated by this Agreement.
- 21. <u>Limitations.</u> Except as specified in this Agreement, nothing in this Agreement shall be construed as giving either Party the right or ability to bind the other or create any joint liability as regards the activities under this Agreement.
- 22. <u>No Assignment of Rights.</u> No rights which either Party has under this Agreement may be assigned to any other person, persons, corporation, or entity without prior written approval of the other Party. Any such transfer or assignment made in violation of this Section shall be void. The terms of this Agreement shall inure to the benefit of the successors to the Parties.
- 23. <u>California Law.</u> All provisions of this Agreement and rights and obligations of the Parties hereto shall be interpreted and construed according to the laws of the State of California.
- 24. <u>Captions Merely Descriptive.</u> Each of the labels, descriptions, or captions attached to and accompanying each of the articles and or subparts contained herein is merely illustrative and used for the convenience and reference of the parties, and is not intended to nor creates and additional rights, duties or obligations due or owed to either party to this Agreement.
- 25. <u>Additional Documents; Cooperation.</u> The Parties agree upon request to execute, acknowledge, and deliver all additional papers and documents reasonably necessary to carry out the intent of this Agreement. The Parties further agree to cooperate with one another to effectuate the terms of this Agreement and the intent of the Parties hereto.
- 26. <u>Easements.</u> SCV WATER's obligation to construct the Construction Project is expressly conditioned upon, in addition to any and all other limitations contained within this Agreement, the receipt by SCV WATER, at no cost to the SCV WATER, of any and all easements deemed reasonably necessary by SCV WATER for the Construction Project or any part thereof.


Exhibit B: Project Description and Maps

Funding for the project will be used to consolidate two small water systems into SCV Water. The project will provide a reliable water supply to Lily of the Valley (LOV) and the Los Angeles Residential Community (LARC).

The project will construct a new 12-inch ductile iron pipeline that connects to the nearest SCV Water pipeline at Shadow Valley Lane and extends approximately 9,600 feet to the frontage of the LARC's property at 29890 Bouquet Canyon Road.

For LARC's connection the project will construct a new 4-inch meter, onsite backflow preventer, and onsite pump station. The onsite pump station will be owned, operated, and maintained by LARC.

For LOV's connection, the project will construct two new 4-inch master meters with associated piping and appurtenances.





Eligible Costs (Grant Funded)

Eligible costs include costs for 9,600 feet of 8-inch ductile iron pipeline with all fire hydrants and other appurtenances as shown on approved 8-inch pipeline plans. Eligible costs will be based on the selected contractor bid price for the 8-inch pipeline.

For LARC's connection, costs include a new 4-inch master meter; and onsite pump station (as shown on pump station plans). SCV Water Facility Capacity fees are included as eligible costs.

For LOV's connection, costs include two new 4-inch master meters, including service laterals. SCV Water Facility Capacity Fees are included as eligible costs.

If bid prices for the eligible project costs exceed grant funding, then SCV Water will request an amendment to the SWRCB Agreement to cover the entirety of eligible cost items for the project in accordance with the SWRCB Agreement Section B.5 Line-Item Adjustments.

If the amendment to the SWRCB Agreement is not sufficient to cover the entirety of eligible Project cost overruns, including change orders during construction, then SCV Water will meet and confer in good faith with LARC and LOV for approval and to apportion the costs for the cost overruns based according to the following formula:

- LARC's allocation is 48.39%
- LOV's allocation is 51.61%

Cost overruns for onsite construction for LARC would be excluded from cost sharing and would be the sole responsibility of LARC.

Ineligible Costs

SCV Water - Ineligible costs are the marginal cost to upsize the pipeline from 8-inch ductile iron pipe to 12-inch ductile iron pipe. The marginal construction costs will be determined by the difference between the selected construction contractor's bid price for the 12-inch pipeline and the 8-inch pipeline.

Lily of the Valley – Ineligible costs are the onsite improvements by Lily of the Valley that will include installation of a backflow preventer after each 4-inch master meter and onsite (customer side) piping to connect to the existing onsite distribution system. Lily of the Valley will be responsible for disconnecting the existing water wells and tanks from the onsite potable water distribution system.

Los Angeles Residential Community – Ineligible costs will include disconnecting the existing water wells from the onsite potable water distribution system.








SUBJECT: Approve a Ratepayer Assistance Pilot Program

SUMMARY

In February 2022, the Finance and Administration (F&A) Committee received a report and presentation on ratepayer assistance programs. At that time, the California Legislature was considering Senate Bill 222 (Dodd) which would have established a Water Rate Assistance Program and Water Rate Assistance Fund to provide water affordability assistance for drinking and wastewater services to low-income ratepayers. SB 222 passed at the end of session. Governor Newsom vetoed the bill because there was "no funding identified," and because it would create "an ongoing program that would require all community water systems and wastewater systems to participate" and "would result in significant General Fund pressures in the billions of dollars to provide such assistance."

As a result of the Governor's veto, the F&A Committee recommended that staff update the presentation for Committee discussion. Staff prepared a discussion and presentation at the January 23, 2023 rescheduled F&A Committee meeting. At that time, the Committee requested some additional information and directed staff to draft a Ratepayer Assistance Pilot Program (Attachment 2), assuming a funding cap of \$100,000 and eligibility parameters, which was presented at the February 27, 2023 rescheduled F&A Committee meeting. The following is a summary of the presentations, as the Committee is seeking approval of the Pilot Program at the April 18, 2023 regular Board meeting.

DISCUSSION

A Ratepayer Assistance Program for a water customer provides bill payment assistance to the ratepayer. Eligibility is commonly based on household income. In Southern California, a common path for determining eligibility is the customer qualifying under the California Alternate Rates for Energy ("CARE") program. Both Southern California Edison (SCE) and Southern California Gas Company (SoCalGas) use the CARE program to determine if a customer qualifies for their payment assistance programs.

Staff performed a search for water districts that adopted a low income or ratepayer assistance program, as well as contacted the Agency's benchmark agencies to find out if those agencies had a program. Eight (8) of the Agency's ten (10) benchmark agencies are retail agencies and of those eight (8), three (3) offer monthly assistance. There are six (6) other public agencies that staff found that offer monthly assistance as shown in Attachment 1. The amount of monthly assistance and the program eligibility vary by agency.

Current SCV Ratepayer Assistance

While SCV Water does not currently operate a ratepayer assistance program targeted to low-income residents, it does provide several measures to be of assistance to ratepayers. First, customers who fall behind on their water bill receive a minimum of 45 days before a late fee will be assessed, and 71 days (from bill date) before a service is shut off. Also, SCV Water offers extended payment plans to help customers who have fallen behind on their water bills to catch up on their past due balance – up to 12 months – to avoid disruption of service.

In addition, SCV Water supports a limited term third-party Low-Income Household Water Assistance Program (LIHWAP) and promotes the program on its water bills and website. The LIHWAP is a federally funded program administered by the State designed to provide financial assistance to low-income Californians to help manage their residential water utility costs. This program offers a maximum of \$2,000 per qualifying household, for past due or current water and wastewater bills and participation requirements include that household income must be 60% or less than the State Median Income. In 2022, for a one-person household, the yearly income to qualify would be less than \$30,776.76. The California Department of Community Services and Development (CSD) administers the LIHWAP and funds are managed and distributed by Horn.

Recently, the CSD approved expanding the threshold of assistance from \$2,000 to \$15,000, but only to those who had not previously received the benefit. Although the Governor vetoed SB 222, the Legislature added an additional \$200 million to the LIHWAP in its 2022-23 budget. The LIHWAP ends in August 2023.

A simple estimate of program cost for SCV Water

Using the CARE income threshold as a starting point, Staff developed a rough estimate of eligibility to assess the potential cost and scale of implementing the Agency's own ratepayer assistance program. According to Santa Clarita Economic Development Corporation in 2022, 7.3% (21,807) of families in the Santa Clarita Valley, out of a population (298,731), lie below the poverty level. Assuming 4 residents per water account, (21,807 divided by 4), the Agency could expect up to 5,452 accounts with household income below the poverty level. This also assumes all customers below the poverty level are responsible for paying a water bill and opt to seek ratepayer assistance.

If the Agency offered assistance of \$10 per month off the fixed monthly charge customer accounts qualified to receive assistance, the monthly ratepayer assistance for 5,452 accounts would be \$54,520 per month, or \$654,240 per year. For example, a customer with a ¾ inch meter would receive \$10 off the current fixed monthly charge of \$20.85, reducing the charge to \$10.85.

Another option would be to assist a fixed number of eligible customers on a first come, first served or lottery basis up to an annual budgeted program cap. For example, if the Agency budgeted for \$200,000 annually for ratepayer assistance, then the first 1,667 eligible customers could receive \$10 per month in ratepayer assistance. If more than 1,667 customers applied, a lottery system could select 1,667 customers. Additional criteria could be used to prioritize selection (such as prioritizing senior citizens, disabled persons or veterans who fall below the poverty level).

Staff requested guidance from the Committee prior to developing a policy on these questions:

- 1. Is there interest in pursuing further development of a draft ratepayer assistance program?
- 2. What is the desired amount of monthly assistance per account?
- 3. What amount of funds would be desired or provided for the program on an annual basis? (Due to Proposition 218, legal counsel has advised the funds cannot come from SCV Water's water rate revenue, and other non-rate revenue sources would need to be identified.)

Staff recommended the following policy guidelines as a consensus to move forward:

- 1. Use the CARE program to determine income eligibility
- 2. Establish a priority for Seniors >62, veterans and the permanently disabled
- 3. Only residential, individually metered accounts will be eligible (1" meter or below)
- 4. Require that the eligibility account (SCE or SoCalGas) be in the same name or service address as the SCV Water account holder
- 5. Require account holders to requalify each fiscal year

Proposition 218 restricts public water providers from using water rate revenue to fund such a program. A number of agencies use some combination of non-water rate revenue, donated funds, and other coordinated assistance program funds to fund a low-income ratepayer assistance program. The Agency intends to designate a portion of the annual non-operating revenue from lease agreements with telecommunication companies that lease Agency property for telecommunications purposes, or rental income received from Agency-owned property ("Program Funds").

Based on the survey of the benchmark agencies that are used for Agency comparison and other assistance programs located from other public water agencies, a credit of \$10 per month off the fixed monthly charge was a common result, which the F&A Committee agreed to be a fair amount for ratepayer assistance.

The F&A Committee requested that staff develop a pilot program and also proposed limiting the Assistance Fund to \$100,000 on an annual basis for a period up to (3) three years. The amount of funding would be approved through the budget process each year and may be increased or decreased on an annual basis. Taking all of this into consideration, staff drafted the attached Ratepayer Assistance Pilot Program as well as the attached Ratepayer Assistance Program Application (Attachment 3).

There may be other methods that can be further researched to fund or offset the ratepayer assistance program expense without impacting current ratepayers. There are a few online fundraising platforms available - such as Donate Kindly, GoFundMe and others - which could enable the Agency to provide a method for interesting parties to make a voluntary donation to the ratepayer assistance program via a link provided on the Agency's website and/or customer newsletter. Staff is also looking to see if the Agency's current credit card processor, iCloud, has a similar feature. This information will take some time to determine if either of these options are viable.

On February 27, 2023, the F&A committee considered staff's recommendation to approve a Ratepayer Assistance Pilot Program as presented.

STRATEGIC PLAN NEXUS

There is not a specific Strategic Plan Objective to implement a ratepayer assistance program. However, the Board, representing the Community, may determine such a program would uphold SCV Water Strategic Plan Goal A: "Implement and communicate policies supporting the social, quality of life, and environmental values of the community."

FINANCIAL CONSIDERATIONS

As noted, an Agency-funded Ratepayer Assistance Program offering \$10/month in fixed charge assistance could cost as much as \$650,000 per year. Alternatively, the funding could be capped at a specific dollar amount, and the assistance would be on a first-come, first-served basis. If the Agency were to allocate \$100,000 annually, approximately 833 accounts at \$10 per month could receive the assistance.

The Agency would have to fund a ratepayer assistance program using non-operating revenues to maintain compliance with Proposition 218. Examples of non-water rate revenue include communication tower lease revenue, property rental income, or unrestricted property taxes. Currently these revenue sources are utilized to reduce the revenue otherwise required from water rates to meet the Agency's cost of service.

RECOMMENDATION

The Finance and Administration Committee recommends that the Board of Directors approve a Ratepayer Assistance Pilot Program.

RATEPAYER ASSISTANCE PROGRAM (PILOT PROGRAM)

1.0 PURPOSE

The Board of Directors of the Santa Clarita Valley Water Agency (the "Agency") recognizes that some Agency residential households, whose household income falls below the federal poverty line, are not current on their water bills or are struggling to pay their water bills. The Agency has developed the Ratepayer Assistance Program (pilot program) to help some low-income residential households stay current on their water bills. The purpose of implementing this financial assistance program is to assist such customers with the monthly payment of their water bills.

The Agency intends to finance the Ratepayer Assistance Program with funds received from lease agreements with telecommunication companies who lease Agency property for telecommunications purposes or rental income received from Agency-owned property ("Program Funds"). These Funds are unrestricted funds and may be used by the Agency for any public purpose.

This pilot program is valid for three fiscal years ("FY"), beginning with FY 2023/24, with an effective date of July 2023 and ending with FY 2025/26, expiring in June 2026.

2.0 POLICY

Establishment of Assistance Fund for Low-Income Residents

- 2.1 The Agency hereby establishes a financial assistance fund for qualifying low-income customers that will be supported with Program Funds approved by the Board of Directors, in its sole discretion, for use in accordance with this policy (the "Assistance Fund"). The Agency shall ensure that the Assistance Fund does not mix with other Agency revenues, including water rate revenues.
- 2.2 The Board of Directors shall approve the amount of funds for the Assistance Fund as part of the budget process for each fiscal year. Approved funding, if any, will be a not-to-exceed amount established for a twelve (12) month period, beginning each fiscal year. The Agency is under no obligation to approve funding for the Assistance Fund or to provide financial assistance to any customers if there are no funds available in the Assistance Fund.
- 2.3 The Agency, in its sole discretion, reserves the rights to reduce amounts available under the Assistance Fund, and any assistance available under that program, in its entirety, upon at least thirty (30) days written notice to participants in the program.

3.0 ASSISTANCE

The Agency will apply a \$10 monthly credit on fixed charges for qualifying residential customer accounts towards their respective monthly water bills for up to a 12-month period during a fiscal year. Financial assistance shall be given to qualifying customers from the priority group as identified in 4.4, on a "first-come, first-served" basis, so long as funds are available and designated by the Board of Directors in each fiscal year. Once all of the authorized funds in a fiscal year are committed to qualifying customers, the Agency is under no obligation to provide any financial assistance to additional customers.

4.0 QUALIFYING CRITERIA

- 4.1 An applicant's primary residence must be the service address on the account for which he or she is seeking financial assistance.
- 4.2 Customers who present evidence that they are enrolled in the Southern California Edison ("Edison") or Southern California Gas ("SoCalGas") California Alternate Rates for Energy ("CARE") programs qualify for financial assistance under this policy. The name and/or service address on the Edison bill or SoCalGas bill reflecting the customer's enrollment in the CARE program must match the name and/or service address on the Agency water bill.
- 4.3 As indicated above, any approved financial assistance will be provided on a fiscal year basis. For continued consideration, a new application must be submitted every fiscal year. Agency staff shall determine deadlines for applications and timing of awards and shall make such information available to the public. The Board of Directors may in its discretion decide whether to authorize contributions of Program Funds to the Assistance Fund or not. If the Board does not authorize contributions in a fiscal year or decides to end the pilot program, the Agency has no obligation to provide any financial assistance to otherwise qualifying customers.
- 4.4 Priority will be given to the following groups meeting the criteria established in
 - a. Seniors, age 62 or greater
 - b. Veterans
 - c. Permanently disabled
- 4.5 If it is projected by Agency staff that there will be available funds in the Assistance Fund after processing the priority group applications, the Assistance Fund will be opened to all eligible customers meeting the qualifying criteria as established in 4.2.

SUBJECT: April 6, 2023 Engineering and Operations Committee Meeting Recap Report

The Engineering and Operations Committee met at 5:30 PM on Thursday, April 6, 2023 in the Summit Circle Engineering Services Section Boardroom located at 26521 Summit Circle. In attendance were Committee Chair William Cooper and Directors Gary Martin, Piotr Orzechowski and Kenneth Petersen. Staff members present were Assistant General Manager Steve Cole; Chief Engineer Courtney Mael; Chief Operating Officer Keith Abercrombie; Manager Matthew Stone; Engineer Wai Lan Lee; Executive Assistants Elizabeth Adler and Leticia Quintero; Principal Engineer Brent Payne and additional SCV Water Agency staff. Two members of the public were present. A copy of the agenda is attached.

Item 1: Pledge of Allegiance – Director Petersen led the Committee in the Pledge of Allegiance.

Item 2: Public Comments – There was no public comment.

Item 3: Review and Consider the Proposed FY 2023/24 and FY 2024/25 Capital Improvement Projects – The Committee and staff discussed the proposed Capital Improvement Projects for FY 2023/24 and FY 2024/25 and staff let the Committee know that the FY 2023/24 and FY 2024/25 Capital Improvement Projects will be presented at a future F&A Committee meeting and then a full Board presentation will be given at a regular Board meeting in May 2023.

Item 4: Recommend Authorization for the Chief Engineer to Execute Water Service Agreements with the Los Angeles Residential Community and Royce Lily of the Valley LLC – There was public comment. The Committee and staff briefly discussed the easement section of the Water Service Agreements and the need to bid for two separate pipe sizes. The Committee recommended a full presentation of the item at the April 18, 2023 regular Board meeting. Staff also noted that Agency legal and state representatives will be present at that Board meeting.

Item 5: Recommend Approval of (1) Adopting a Resolution Authorizing a Purchase Order to Hunsaker & Associates Los Angeles, Inc. for Planning Services for the N-Wells Drainage Improvements Project, and (2) Finding That the Authorization is Not a Project Subject to CEQA Guidelines Section 15262 – The Committee and staff briefly discussed the current drainage system design, why we are needing to address this issue at the present time and whether or not we currently have easements. The Committee recommended the item be placed on the Consent Calendar at the May 2, 2023 regular Board meeting.

Item 6: Monthly Operations and Production Report – Staff and the Committee reviewed the Operations and Production Report.

Item 7: Capital Improvement Projects Construction Status Report – Staff and the Committee reviewed the Capital Improvement Projects Construction Status Report.

Item 8: Committee Planning Calendar – Staff and the Committee reviewed the FY 2022/23 Committee Planning Calendar.

Item 9: General Report on Treatment, Distribution, Operations and Maintenance Services Section Activities – Keith Abercrombie shared with the Committee an update on turbidity in the lakes and the treatment plants and while turbidity is still high, the numbers are significantly lower than they have been in previous months. SCVWA is continuing to work with DWR and MWD on turbidity and what improvements can be made as these events will be an ongoing concern. Lastly, Keith shared that Operations has a team that routinely performs inspections on pressure reducing valves on tanks to insure proper function and longevity of the systems.

Item 10: General Report on Engineering Services Section Activities – Courtney Mael briefly updated the Committee that we are eligible for an ACWA award for the Valley Center Wells. Courtney also updated the Committee on the recent offer that was extended to a candidate for the Assistant Engineer position and the increase in planning projects. Lastly, Courtney shared his appreciation regarding being involved in the Water Academy and how much he appreciated the staff and the public's participation and engaging questions.

Item 11: Adjournment – The meeting adjourned at 7:08 PM.
