Minutes of the Annual Meeting of the Santa Clarita Valley Water Agency Financing Corporation – February 15, 2022

An annual meeting of the Santa Clarita Valley Water Agency Financing Corporation was held via teleconference at 10:33 PM on Tuesday, February 15, 2022. A copy of the Agenda is inserted in the Minute Book of the Agency preceding these minutes.

DIRECTORS PRESENT: Jerry Gladbach, Gary Martin, Dan Mortensen and Matthew Stone.

DIRECTORS ABSENT: William Cooper.

Also present via teleconference: Administrative Technician Terri Bell, Assistant General Manager Steve Cole, Board Secretary April Jacobs, General Counsel Joe Byrne, General Manager Matt Stone, Director of Finance and Administration Rochelle Patterson, additional SCV Water staff and members of the public.

SUBJECT: Election of Vice President to the Santa Clarita Valley Water Agency Financing

Corporation for the Remaining 2022 Calendar Year

SUMMARY AND DISCUSSION

The Santa Clarita Valley Water Agency Financing Corporation (Financing Corporation) is a nonprofit public benefit corporation organized to provide assistance to SCV Water by financing facilities. The Financing Corporation has a Board of Directors that consists of the SCV Water President and two Vice Presidents, one Director and the General Manager. The SCV Water General Manager remains a Director of the Financing Corporation so long as he or she is the General Manager. For the other Financing Corporation Directors, the term matches the Director's term as a SCV Water Director, unless a vacancy occurs during the Director's term, in which case the SCV Water Board President appoints a replacement.

Dan Mortensen, the Agency's Vice President, resigned from the SCV Water Board in March 2022, leaving a vacancy on the Financing Corporation Board. Mr. Mortensen was the Vice President of the Financing Corporation at the time. Director Piotr Orzechowski is now a member of the Financing Corporation Board due to his recent election as the second Vice President to the SCV Water Board on June 7, 2022, and it would be proper to elect a new Vice President to the Financing Corporation Board to finish the 2022 calendar year.

The current Board members and officers as of June 2022 are:

William Cooper – President Jerry Gladbach – Director
Gary Martin – Director Piotr Orzechowski – Director

Matthew Stone – General Manager

The Financing Corporation will need to elect a Vice President for the remaining 2022 calendar year.
