Description of Nature, Purpose and Beneficiaries of Project:

The project consists of the construction of up to 17 new monitoring wells at 10 locations, which would be used to conduct basic data collection and resource evaluation activities related to assessing groundwater flow and water quality conditions in key unmonitored portions of the Upper Santa Clara River Groundwater Basin.

Reasons why project is exempt:

The project involves the installation of 17 new monitoring wells at 10 locations, each of which would have a minimal aboveground permanent footprint with limited aboveground components. The collective permanent footprint at the 10 locations would be approximately 90 square feet. Therefore, a Class 3 CE is applicable. In addition, the primary purpose of the monitoring wells is to gather additional data on the hydrogeology, groundwater elevations and flow, and groundwater quality in critical areas of the Upper Santa Clara River Groundwater Basin. The proposed well sites are located in disturbed, urbanized areas, and construction and operation would not result in a serious or major disturbance to an environmental resource. Therefore, a Class 6 CE is applicable. Furthermore, none of the exceptions outlined in CEQA Guidelines Section 15300.2 apply to the proposed project.
