Description of Nature, Purpose and Beneficiaries of Project:

The project involves construction of the proposed Newhall Wells Groundwater Treatment Plant, which would have a treatment capacity of approximately 7.78 million gallons per day; upgrades to the existing Newhall Disinfection Facility; re-equipping of the existing Well N-11, which is currently offline; upsizing of well pumps and electrical infrastructure at the existing Wells N-11, N-12, and N-13; installation of a 2,700-linear-foot, 24-inch potable water pipeline within Railroad Avenue, and potential reconfiguration of the median in Railroad Avenue to include left turn lanes.


Reasons why project is exempt:
