### Qualifications:

- Santa Clarita Valley Water Agency (SCVWA) is offering rebates for the following products and irrigation efficiency upgrades:
  - 75% Master Pressure Regulation Device(s) (See Qualifying Products List and Program Rules on [conserve.yourscvwater.com](http://conserve.yourscvwater.com)), (Does not include master pressure regulation devices for indoor pressure management).
  - Up To \$12 for HE Irrigation Nozzles (See Qualifying Products List and Program Rules on [conserve.yourscvwater.com](http://conserve.yourscvwater.com));
  - \$10.00 per Body Rebate for Qualifying Pressure Regulating Bodies with Check Valve or Check Valve Inserts (See Qualifying Products List and Program Rules);
  - 75¢/sq.ft. for DRIP Conversion projects (See Qualifying DRIP Product Types List and Program Rules on [conserve.yourscvwater.com](http://conserve.yourscvwater.com)).
- The customer's property must be in the SCVWA service area and customer must be in good standing.
- HELP devices must be purchased on or after July 1, 2021, or on or before December 31st, 2022. Extensions on this rebate are at the discretion of SCVWA. Rebates available until funding runs out and are awarded on a first come, first serve basis. Rebate requests larger than \$2,500.00 require prior authorization from the SCVWA Sustainability Manager or designated SCVWA staff.
- The HELP devices may be purchased at any retail or wholesale outlet that sells HE irrigation equipment.
- Submit your original sales receipt to SCVWA along with other necessary documentation to substantiate the HE device(s) purchased are qualifying HELP Rebate products. Your documentation must include the date of purchase, purchase price, product/model information.
  - Customers may combine HELP Rebates with the Lawn Replacement Incentive Program. Customers choosing to combine rebates must adhere to all requirements listed in this document and those identified in the Terms and Conditions, Process Guidelines, and Design Guidelines of the Lawn Replacement Incentive Program.
- HELP rebate voucher will be completed & executed by the customer when HELP receipts are emailed, walked into, or delivered to our office. HELP Rebate requests may also be submitted along with documentation process utilized in the Lawn Replacement Incentive Program ([conserve.yourscvwater.com](http://conserve.yourscvwater.com) or [yourscvwater.dropletprograms.com](http://yourscvwater.dropletprograms.com))
- Rebate amounts will not exceed the total cost of the parts of and pieces identified (Qualified Pressure Regulating Bodies with Check Valves, Check Valve Inserts, and Drip Conversion Exempt) in the accompanying receipts submitted by the customer.
- Please allow 12 weeks for your completed application to be processed.
- REBATES MAY BE ISSUED AS A CREDIT ON YOUR WATER BILL OR A CHECK, AS DETERMINED BY SCVWA.**
- SCVWA will credit up to an annual maximum allowable rebate amount 10,000.00 per commercial or commercial agriculture account (Excluding Taxes, Labor, and Non-Qualifying Devices).
- An IRS Form W-9 must be completed by all customers to receive a rebate. Additionally, the Internal Revenue Service requires rebate program participants receiving \$600 or more in rebates to be issued an IRS Form 1099 unless exemptions apply. Tax Payer ID numbers provided as part of the application process are held in confidence and are not divulged or otherwise conveyed to outside individuals or organizations.
- As an additional service to our customers, SCVWA has contracted with WaterWise Consulting to perform FREE Residential or Commercial Water Check-Ups.
